ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on February 15, 1956, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission".

NOW, on this 14th day of March, 1956, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for the creation of a new pool in Rio Arriba County, New Mexico, for the production of gas from the Pictured Cliffs formation, said pool to bear the designation Otero-Pictured Cliffs Gas Pool. Said Otero-Pictured Cliffs Gas Pool was discovered by J. J. Harris, Jicarilla #1, located in the SE/4 of the NE/4 of Section 28, Township 24 North, Range 5 West, NMPM. It was completed February 1, 1955. The depth of the casing shoe is 2,218'.

(3) That there is need for certain extensions to the Blanco Mesaverde Pool, the Aztec-Pictured Cliffs Pool, the Ballard-Pictured Cliffs Pool, the Fulcher Kutz-Pictured Cliffs Pool, the West Kutz-Pictured Cliffs Pool, and the South Blanco-Pictured Cliffs Pool, all in San Juan and/or Rio Arriba Counties, New Mexico.

IT IS THEREFORE ORDERED:

(a) That a new pool in Rio Arriba County, New Mexico, classified as a gas pool for Pictured Cliffs production, be and the same is hereby created and designated as the Otero-Pictured Cliffs Gas Pool, consisting of the following described area:
