ORDER OF THE COMMISSION

FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That there is need for certain extensions to the Aztec-Pictured Cliffs Pool, the West Kutz-Pictured Cliffs Pool, and the Bisti-Lower Gallup Cil Pool in San Juan County, New Mexico the Otero-Pictured Cliffs Pool and the Tapicito-Pictured Cliffs Pool in Rio Arriba County, New Mexico, and the Ballard-Pictured Cliffs Pool in Rio Arriba and San Juan Counties, New Mexico.
