In the matter of the application of the Oil Conservation Commission of New Mexico upon its own motion for an order for the extension of existing pools in Lea, Chaves, Eddy and Roosevelt Counties, New Mexico, and giving notice to all persons and parties interested in the subject matter thereof to appear and show cause why such extensions should not be made.

(a) Extend the Artesia pool boundary in Eddy County, New Mexico, to include therein:

Twp. 17 South, Range 28 East
S/2 NW/4 of Section 36 and such other etc.

(b) Extend the Atoka pool boundary in Eddy County, New Mexico, to include therein:

Twp. 18 South, Range 26 East
W/2 NW/4 of Section 12 and such other etc.

(c) Extend the Brown pool boundary in Chaves County, New Mexico, to include therein:

Twp. 10 South, Range 26 East
SE/4 SE/4 Sec. 22; S/2 SW/4 Sec. 23 and such other etc.

(d) Extend the Cass pool boundary in Lea County, New Mexico, to include therein:

Twp. 20 South, Range 37 East
SW/4 of Sec. 14; SE/4 of Sec. 15

(e) Extend the Dollarhide-Drinkard pool boundary in Lea County, New Mexico, to include therein:

Twp. 24 South, Range 38 East
N/2 NE/4 of Section 19 and such other etc.

(f) Extend the E-K Queen pool boundary in Lea County, New Mexico, to include therein:

Twp. 18 South, Range 3, East
NW/4 of Section 23 and such other etc.

(g) Extend the Fowler-Favonien pool boundary in Lea County, New Mexico, to include therein:

Twp. 24 South, Range 37 East
W/2 SW/4 of Section 10 and such other etc.

(h) Extend the Gladiola-Devonian pool boundary in Lea County, New Mexico, to include therein:

Twp. 12 South, Range 38 East
N/2 SE/4 & S/2 NE/4 of Section 18 and such other etc.
