ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on May 16, 1957, at Hobbs, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 20th day of May, 1957, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Cass Pool, the Dollarhide-Drinkard Pool, the E-K Queen Pool, the Fowler-Devonian Pool, the Gladiola Pool, and the Roberts Pool, all in Lea County, New Mexico, to the Brown Pool in Chaves County, New Mexico, to the Artesia Pool and the Atoka Pool, both in Eddy County, New Mexico, and to the Milnesand-Pennsylvanian Pool in Roosevelt County, New Mexico.

(3) That the advertised extension of the South High Lonesome Pool in Eddy County, New Mexico, should be dismissed pending further study.

IT IS THEREFORE ORDERED:

(a) That the Artesia Pool in Eddy County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:
