Porter Mr. Murray Morgan <u>T R A N S C R I P T</u> OF <u>PROCEEDINGS</u> MR. PORTER: Take up next Case 1256. (Witness sworn.) ELVIS UTZ called as a witness, having been first duly sworn on oath, testified as follows: DIRECT EXAMINATION BY MR. COOLEY: Q State your name and position for the record, please. A Elvis A. Utz, engineer with the Oil Conservation Commission. Q Mr. Utz, in your official capacity as engineer for the New Mexico Oil Conservation Commission, have you had an opportunity to make a study for the creation and extension of certain pools in Northwest New Mexico? A Yes, I have. Q Do you have any recommendations concerning the creation of a new gas pool for Fruitland production in Township 30 North, Range 12 West? Yes, I have. I recommend the creation of a new gas pool Α to be designated as the Flora Vista Fruitland Gas Pool, which is

created on the basis of five wells capable of producing in the area, of which five wells, the discovery well was the Northwest Production No. 3-10, Blanco 30-12, 1510 feet from the south, and 990 feet from the West, Section 10, 30 North, 12 West, which had an absolute open flow of 10631 MCF per day with a shut-in pressure of 630 pounds in nine days.

Q Mr. Utz, what would you recommend as the horizontal limits for the proposed Flora Vista Fruitland Pool?

A Township 30 North, Range 12 West, Section 9, All, Section 10, All.

Q Do you have any recommendations concerning the extension of the Aztec Pictured Cliff's Pool?

A I recommend that the Aztec Pictured Cliffs Gas Pool be extended as advertised on the basis of one well capable to producing from that area.

Q Do you have any recommendations concerning the extension on the Ballard Pictured Cliffs Pool?

A I recommend that the Ballard Pictured Cliffs Gas Pool be extended as advertised on the basis of one well capable of producing from this pool.

Q What are your recommendations concerning the extension of the South Blanco Pictured Cliffs Pool?

A I recommend that the South Blanco Pictured Cliffs Gas Pool be extended as advertised on the basis of five wells capable of producing from this pool. Q What are your recommendations of the Bisti Lower Gallup Oil Pool?

A I recommend that the Bisti Lower Gallup Oil Pool be extended as advertised on the basis of one well capable of producing from this pool.

Q What are your recommendations concerning the extension of the Verde Gallup Oil Pool?

A I recommend that the Verde Gallup Oil Pool be extended as advertised on the basis of two wells capable of producing from this pool.

Q Do you have any further recommendations?

A I have no further recommendations. I do have an exhibit which states the creation and extensions and the wells in which those creations and extensions are based.

Q Was this exhibit prepared by or under your supervision?

A Yes, it was.

Q How is that exhibit identified?

A As Exhibit No. 1.

Q I would like to offer at this time Exhibit No. 1 in Case 1256.

MR. PORTER: Without objection, it will be admitted.

MR. COOLEY: No further questions.

MR. PORTER: Anyone have a question of Mr. Utz? The witness may be excused and there being nothing further in this case, we will take it under advisement and the hearing is adjourned.
