ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on May 16, 1957, at Hobbs, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 29th day of May, 1957, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for the creation of a new pool in San Juan County, New Mexico for the production of gas from the Fruitland formation, said pool to bear the designation Flora Vista-Fruitland Pool. Said Flora Vista-Fruitland Pool was discovered by Northwest Production Corporation Blanco 30-12 Well No. 3-10, located in the NW/4 SW/4 Section 10, Township 30 North, Range 12 West, NMPM. It was completed December 28, 1956.

(3) That there is need for certain extensions to the Aztec-Pictured Cliffs Pool, the Bisti-Lower Gallup Oil Pool and the Verde-Gallup Oil Pool, all in San Juan County, New Mexico and to the Ballard-Pictured Cliffs Pool and the South Blanco-Pictured Cliffs Pool, both in Rio Arriba and San Juan Counties, New Mexico.

IT IS THEREFORE ORDERED:

(a) That a new pool in San Juan County, New Mexico, classified as a gas pool for Fruitland production, be and the same is hereby created and designated as the Flora Vista-Fruitland Pool consisting of the following described area:

TOWNSHIP 30 NORTH, RANGE 12 WEST, NMPM
Sections 9 and 10: All

(b) That the Aztec-Pictured Cliffs Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 30 NORTH, RANGE 11 WEST, NMPM
Section 6: SE/4

(c) That the Ballard-Pictured Cliffs Pool in Rio Arriba and San Juan Counties, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 25 NORTH, RANGE 7 WEST, NMPM
Section 19: S/2

(d) That the South Blanco-Pictured Cliffs Pool in San Juan and Rio Arriba Counties, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 25 NORTH, RANGE 5 WEST, NMPM
Section 26: SW/4
Section 27: S/2
Section 28: S/2
Section 33: All

TOWNSHIP 26 NORTH, RANGE 5 WEST, NMPM
Section 23: SW/4
Section 26: W/2
Section 35: NW/4

(e) That the Bisti-Lower Gallup Oil Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:


TOWNSHIP 26 NORTH, RANGE 13 WEST, NMPM
Section 26: SE/4

(f) That the Verde-Gallup Oil Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 31 NORTH, RANGE 15 WEST, NMPM
Section 12: NW/4 and SE/4
