Dear Randall:

In checking the records on the Western Oil Fields, Inc., Amanda Sims 1-I, we find that our file shows it still to be a dual completion in the Drinkard Oil Pool and Tubb Gas Pool. We have records of the work done in connection with dualling the well on Forms C-103 and C-105 and a C-104 approved by our Hobbs Office on February 3rd, 1954.

Checking further, we find that the well was assigned a gas allowable in the Tubb Pool on February 19, 1954, which allowable was continued through December, 1956, but we are unable to find any record of gas production from the Tubb zone during that time. Our well file does not indicate that the Tubb perforations have been squeezed off. We note, however, that it is still being produced as a Drinkard oil well.

We would appreciate it very much if you would check with the local representatives of Western and find out the present status of the well and have them file the necessary forms to bring our file up to date.

Dear Mr. Porter:

Your letter of May 8, 1957 requested that this office check the present status of the Western Oil Fields, Inc. Acenda Sine No. 1-1 in Section 25, T-22-S, R-37-E.

This well is presently a dual completion in the Drinkard and Tubb formations as authorized by EC Order No. 65. However by gas supplement No. 17-SE dated December 26, 1956 this well was removed from the gas schedule due to lack of production since 1954.

Upon receipt of your letter Mr. Paul White of Western Oil Fields, Inc. was contacted in regard to this matter. Mr. White has informed me that the well was perforated 100 feet to low in the Tubb section, and is not capable of producing into the gas system. However due to the smallness in size of their tract and apparent inability to communitize with offset operators, no remedial work has been contemplated. However, Mr. White has assured me that a Form G-103 would be filed this date to set forth the above facts and request temporary abandonment of this zone.
