T R A N S C R I P T O F P R O C E E D I N G S

MR. PAYNE: Northwestern New Mexico nomenclature case calling for an order extending existing pools in San Juan, Sandoval and Rio Arriba Counties, New Mexico.

(Witness sworn)

A. R. KENDRICKS,

called as a witness, having been first duly sworn, testified as follows:

DIRECT EXAMINATION

BY MR. PAYNE:

Q Will the witness please state his name and position?

A A. R. Kendricks, engineer for the Oil Conservation Commission.

Q Mr. Kendricks, have you made a study concerning the necessity or desirability of extending existing pools in San Juan, Sandoval, and Rio Arriba Counties, New Mexico?

A I have.

Q What are your recommendations concerning extension of the Ballard-Pictured Cliffs Pool?

A I recommend that it be extended as shown in Paragraph (a) of Exhibit 1, on the basis of six wells capable of producing from that pool.

Q What are your recommendations concerning extension of the South Blanco-Pictured Cliffs Pool?

A I recommend that it be extended as shown in Paragraph (b) of Exhibit 1, on the basis of two wells capable of producing from that pool.

Q What are your recommendations concerning extension of the Chimney Rock-Gallup Oil Pool?

A I recommend it be extended as shown in Paragraph (c) of

Exhibit 1, on the basis of two wells producing from that pool.

Q What are your recommendations concerning extension of the Horseshoe-Gallup Oil Pool?

A I recommend it be extended as shown in Paragraph (d) of Exhibit 1, on the basis of twelve wells capable of producing from that pool.

Q What are your recommendations concerning extension of the Verde-Gallup Oil Pool?

A I recommend it be extended as shown in Paragraph (e) of Exhibit 1, on the basis of two wells capable of producing from that pool.

Q What are your recommendations concerning extension of the Angels Peak-Dakota Pool?

A I recommend it be extended as shown in Paragraph (f) of Exhibit 1, on the basis of one well producing from that pool.

Q Have you prepared an Exhibit substantiating your recommendations?

A I have.

Q How is that designated, Mr. Kendricks?

A Exhibit 1, Case 1671.

MR. PAYNE: I move for the introduction of Case 1671 into evidence.

MR. PORTER: If there is no objection, it will be admitted.

MR. PAYNE: That concludes our case.

MR. PORTER: Anyone have a question of the witness? The witness may be excused.

(Witness excused)

MR. PORTER: Nothing further in this case; we will take the case under advisement and recess the hearing.
