

Gentlemen:

The Remuda Basin Unit comprises 8,572.18 acres, more or less, located in Eddy County, New Mexico and was approved by the Secretary of the Interior on May 20, 1960, and by the Commissioner of Public Lands of the State of New Mexico on March 29, 1960.

This letter is written by Texaco Inc., Unit Operator, as formal application for your approval to terminate the subject unit, pursuant to Article 20(b) of the Unit Agreement.

As your records will indicate, the Remuda Basin Unit Well No. 1 (NW/4 SE/4 Section 24, T-23-S, R-29-E), was completed on December 17, 1960, in the Wolfcamp formation after being drilled to the Devonian objective depth of 15,141'. On initial potential the well flowed 72 BOPD from perforations through the interval 11,111'-180'.

As production declined rapidly, the Wolfcamp perforations were reacidized in October, 1961 and the well repotentialled flowing only 31 BOPD. In a further effort to increase the wells productivity, additional section from 11,419'-452' was selectively perforated and acidized in November, 1962, without materially increasing the well's production. Cumulative oil production to November 1, 1962,

has been 5,149 barrels. Because of the low production capacity of this well, it has been considered at all times to be not capable of production in paying quantities as defined by the Unit Agreement and therefore produced on a lease, rather than a unit basis.

Under the terms of the Remuda Basin Unit Agreement, a second exploratory well was to be commenced by June 17, 1961. This obligatory commencement date was extended for three successive six month periods to December 17, 1962, primarily to allow further evaluation of the unitized lands. During this period, Texaco reworked the Wolfcamp formation as hereinabove mentioned, conducted evaluations concerning possible re-completion in other formations, and correlated regional geological studies with seismic and other data in an effort to justify further development of the unitized lands. During the drilling of Unit Well No. 1, twelve drill-stem tests which ranged in depth from 6,710' to total depth were conducted with none of the tests indicating commercial production. The performance history of the Remuda Basin Unit Well No. 1 taken in conjunction with the other data studied did not indicate favorable conditions which would justify additional development within the unit area, and consequently, the second well was not commenced.

For the reasons outlined herein, it has been determined that the unitized land is incapable of production of unitized substances in paying quantities in the formations tested and Texaco, as Unit Operator, hereby respectfully requests your approval to terminate the Remuda Basin Unit pursuant to Provision 20(b) of the Unit Agreement. We would further request the termination be made effective the first day of the month next following your approval. All working interest owners in the Unit Area were notified by letter of September 26, 1962, a copy of which is attached, that Texaco proposed to voluntarily terminate the unit and no objections to this proposal were received.

Gentlemen:

Texaco, as unit operator, recently completed its first exploratory attempt on the unit area identified as the Unit Well No. 1. This well was completed on December 17, 1960, in the Wolfcamp formation from 11,111' - 11,180' at a location in the NW/4 SE/4 of Section 24, 23-S, 29-E, Eddy County, New Mexico.

This well at completion indicated a flowing potential of 77 barrels of oil per day. This recovery has not improved and operator has determined that production in paying quantities has not been found in the Unit Well No. 1. Production from this well will, therefore, be distributed on a lease ownership basis.
