ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on February 17, 1960, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 17th day of February, 1960, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Gavilan-Pictured Cliffs Pool, the Otero-Chacra Pool and the South Blanco-Dakota Pool, all in Rio Arriba County, New Mexico; to the Aztec-Fruitland Pool, the Aztec-Pictured Cliffs Pool, the Fulcher Kutz-Pictured Cliffs Pool, the Angels Peak-Gallup Oil Pool, the Horseshoe-Gallup Oil Pool, the Verde-Gallup Oil Pool, the Angels Peak-Dakota Pool, and the West Kutz-Dakota Pool, all in San Juan County, New Mexico; to the South Blanco-Pictured Cliffs Pool in Rio Arriba and San Juan Counties, New Mexico; and to the Ballard-Pictured Cliffs Pool in Rio Arriba, Sandoval, and San Juan Counties, New Mexico.

IT IS THEREFORE ORDERED:


