### ORDER OF THE COMMISSION

## BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on May 18, 1960, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 20th day of May, 1960, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

## FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That there is need for certain extensions to the Escrito-Gallup Oil Pool, the Puerto-Chiquito Oil Pool and the South Blanco-Dakota Pool in Rio Arriba County, New Mexico, to the Aztec-Pictured Cliffs Pool, the Horseshoe-Gallup Oil Pool, the Totah-Gallup Oil Pool, the Verde-Gallup Oil Pool, the Angels Peak-Dakota Pool, the West Blanco-Dakota Pool and the West Kutz-Dakota Pool in San Juan County, New Mexico, and to the Blanco-Mesaverde Pool in Rio Arriba and San Juan Counties, New Mexico.

### IT IS THEREFORE ORDERED:
