ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on February 15, 1961, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 17th day of February, 1961, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FIRDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That there is need for certain extensions to the Devils Fork-Gallup Pool in Rio Arriba County, New Mexico, and to the Blanco-Pictured Cliffs Pool, to the Cha Cha-Gallup Oil Pool, to the Horseshoe-Gallup Oil Pool, to the Rutz-Gallup Oil Pool and to the Shiprock-Gallup Oil Pool in San Juan County, New Mexico, and to the Blanco-Mesawerde Pool and to the Escrito-Gallup Oil Pool, in Rio Arriba and San Juan Counties, New Mexico, and to the Basin-Dakota Pool in Rio Arriba, San Juan and Sandoval Counties, New Mexico.

IT IS THEREPORE ORDERED:

(a) That the Blanco-Pictured Cliffs Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

(b) That the Blanco-Mesaverde Pool in Rio Arriba and San Juan Counties, New Nexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

(c) That the Cha Cha-Gallup Gil Pool in San Juan County, New Mexico, as beretofore classified, defined, and described, be and the same is hereby extended to include therein:

(e) That the Escrito-Gallup Oil Pool in Rio Arriba and San Juan Counties, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

(f) That the Horseshoe-Gallup Oil Pool in Sam Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

Section 3: NE/4 SW/4 and SW/4 SE/4 Section 10: NE/4 NE/4

(g) That the Natz-Gallup Oil Pool in San Juan County, New Maxico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

(h) That the Shiprock-Gallup Gil Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

(i) That the Basin-Dakota Pool in Rio Arriba, Sandoval and San Juan Counties. New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 23 MORTH, RANGE 5 WEST, MNPM Section 21: All
