ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on May 17, 1961, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this <u>19th</u> day of May, 1961, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Cha-Gallup Oil Pool, to the Horseshoe-Gallup Oil Pool and to the Totah-Gallup Oil Pool in San Juan County, New Mexico and to the Escrito-Gallup Oil Pool in Rio Arriba and San Juan Counties, New Mexico.

IT IS THEREFORE ORDERED:

(a) That the Cha Cha-Gallup Oil Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

(b) That the Escrito-Gallup Oil Pool in Ric Arriba and San Juan Counties, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

> TOWNSHIP 24 NORTH, RANGE 7 WEST, NMPM Section 7: S/2 SW/4 Section 15: SE/4 SW/4 Section 16: N/2 SW/4 Section 19: SE/4 NE/4 TOWNSHIP 24 NORTH, RANGE 8 WEST, NMPM Section 12: E/2 SE/4 Section 13: SE/4 NE/4

(c) That the Horseshoe-Gallup Oil Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

> TOWNSHIP 31 NORTH, RANGE 16 WEST, NMPM Section 35: NW/4 NE/4, NE/4 NW/4, E/2 SW/4 and W/2 SE/4

(d) That the Totah-Gallup Oil Pool in San Juan County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 29 NORTH, RANGE 13 WEST, NMPM Section 19: 8/2 Section 20: SW/4

IT IS FURTHER ORDERED:

That the effective date of this order and of all the extensions herein shall be June 1, 1961. -3-CASE No. 2279 Order No. R-1982


