TOWNSHIP 18 NORTH, RANGE 3 WEST Section 31: SE/4 Sections 32, and 33: All



Pursuant to the telephone conversation between our Mr. Nantker and your Mr. Nutter, who was the Hearing Examiner in the above-mentioned case, we propose to expand the Cabezon Unit as outlined in the letter to the United States Geological Survey attached hereto. Pursuant to Paragraph 4(b) of the Order, the Secretary-Director can give administrative approval to the expansion of the Cabezon Unit. You will note that there are no State lands involved in the expanded Area, but due to the fact that we plan to drill an additional well if this expansion is approved, we feel that it would benefit State acreage off the crest of the structure as shown in the attached Geological Report.

Gentlemen:

On March 19, 1962, Shell Oil Company as Unit Operator of the Cabezon Unit received preliminary approval from the United States Geological Survey, the Commissioner of Public Lands, and the Oil and Gas Conservation Commission of the State of New Mexico to the expansion of our Cabezon Unit Area to the north and west, subject to our complying with the provisions of Section 2 of said Unit Agreement. In order to complete geophysical operations in the area and due to an unfavorable cash position, Shell Oil Company found it necessary to obtain a six-month extension of the second well obligation to December 13, 1962. A second extension, to June 13, 1963, was obtained on November 27, 1962, in order to allow Shell Oil Company additional time to complete negotiations for outside financing with which to drill the second Unit well.

The proposed area of expansion embraces 9,601.69 acres, of which 8,641.68 acres or 90 per cent is Federal acreage; 480.01 acres or 5 per cent is Navajo Indian Allotted land; and 480.00 acres or 5 per cent is Fee acreage.

Clyde B. Harvey, owner of three Federal oil and gas leases designated as Tracts 42, 43 and 44; Alex J. Keller, owner of a Federal oil and gas lease designated as Tract No. 45; Pauline Swinehart, owner of a Federal oil and gas lease designated as Tract No. 74; and Beard Oil Company, owner of a Federal oil and gas lease designated as Tract No. 61, were invited to commit their working interests to the Unit and declined to join. One Fee owner, Mrs. Romelia Maestas, designated as Tract No. 84, was invited to join the Unit or decline; however, we received no answer from this party. We have received Consents and Joinders from all the overriding royalty interest holders on the lands committed to the expanded area.

- 6. Commitment of Interests to the Cabezon Unit Operating Agreement executed by the working interest owners.
- 7. Commitment of Interests to the Cabezon Unit Agreement executed by the working interest owners.
- 8. Letters from working interest owners who did not consent to joining the Unit.
