ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on May 10, 1962, at Santa Fe, New Mexico, before Daniel S. Nutter, Examiner duly appointed by the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission," in accordance with Rule 1214 of the Commission Rules and Regulations.

NOW, on this 21st day of June, 1962, the Commission, a quorum being present, having considered the application, the evidence adduced, and the recommendations of the Examiner, Daniel 3. Nutter, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That the applicant, Gulf Oil Corporation, seeks permission to complete its J. F. Janda (NCT-F) Well No. 6, located in Unit D of Section 4, Township 22 South, Range 36 East, NMPM, Lea County, New Mexico, as a dual completion (conventional) in the Jalmat Gas Pool and in the South Eunice Oil Pool with the production of oil from the Jalmat Gas Pool to be through a string of 1 1/4-inch tubing and the production of oil from the South Eunice Oil Pool to be through a parallel string of 2 3/8-inch tubing.
- (3) That the mechanics of the proposed dual completion are feasible and in accord with good conservation practices.
- (4) That approval of the subject application will neither cause waste nor impair correlative rights.

IT IS THEREFORE ORDERED:

(1) That the applicant, Gulf Oil Corporation, is hereby authorized to complete its J. F. Janda (NCT-F) Well No. 6, located

in Unit D of Section 4, Township 22 South, Range 36 East, NMPM, Lea County, New Mexico, as a dual completion (conventional) in such a manner as to permit the production of oil from the Jalmat Gas Pool through a string of 1 1/4-inch tubing and the production of oil from the South Eunice Oil Pool through a parallel string of 2 3/8-inch tubing.

PROVIDED HOWEVER, That the applicant shall complete, operate and produce said well in accordance with the provisions of Rule 112-A of the Commission Rules and Regulations.

PROVIDED FURTHER, That the applicant shall take packer-leakage tests upon completion and annually thereafter during the Gas-Oil Ratio Test Period for the South Eunice Oil Pool.

(2) That jurisdiction of this cause is retained for the entry of such further orders as the Commission may deem necessary.
