

CASE 10277: In the matter of the hearing called by Oil Conservation Division on the own motion for an order creating, designating, discovery allowable and extending certain pools in Lea County, New Mexico.


- (a) CREATE a new pool in Lea County, New Mexico, classified as an oil pool for Queen production and designated as the Buffalo-Queen Pool. 

TOWNSHIP 24 South RANGE 37 East NMPM















TOWNSHIP 18 South RANGE 33 East NMPM




















