

APPLICATION

COMES NOW BTA OIL PRODUCERS, through its undersigned attorneys, hereby makes application to the Oil Conservation Division for authority to simultaneously dedicate two gas wells in Lea County, New Mexico and in support of this application states:

1. Applicant is the operator of the 320-acre standard gas spacing and proration unit comprised of the S/2 of Section 34, Township 22 South, Range 34 East, Antelope Ridge-Atoka Field, N.M.P.M., Lea County, New Mexico, which is dedicated to the BTA Maxus B Well No. 1 located 660 feet from the South and East lines of Section 34.

2. Pursuant to the provisions of Division Order No. R-9009, the Maxus B Well No. 2 located 990 feet from the South line and 1,980 feet from the West line of Section 34 was shut in on January 4, 1990 when the Maxus B No. 3 Well in the NE/4 of Section 34 was completed.

3. Both wells in the S/2 of this section are capable of only marginal production with the Maxus B No. 1 producing at a current rate of 800 Mcf per day and the Maxus B No. 2 producing 325 Mcf per day when shut in.

4. BTA seeks authority to return the 8026 JV-P Maxus B Well No. 2 to production at a rate not to exceed an average of 500 MCFPD on a monthly basis.


5. The S/2 of Section 34, Township 22 South, Range 34 East will be simultaneously dedicated to the 8026 JV-P Maxus B Wells No. 1 and 2.

6. Approval of this application will result in more efficient recovery of the reserves underlying this tract and will otherwise be in the best interest of conservation, the prevention of waste and the protection of correlative rights.

WHEREFORE, Applicant requests that this application be set for hearing before a duly appointed Examiner of the Oil Conservation Division on December 19, 1991 and, after notice and hearing as required by law, the Division enter its Order granting this application.
