Enclosed for your further handling is an executed copy of that certain Farmout Agreement regarding Mewbourne's acreage under the captioned land in support of Maralo's West Corbin 13 Federal #1 well to be drilled in the SE/4SE/4 of the subject Section 13 to test the Wolfcamp formation.

As the referenced agreement was undated, I inserted "15th" in the appropriate space above "this day" on line (1) of the agreement. Also please note on Page (1), under Provision I, Test Well, first paragraph on lines (8) and (9) I inserted "but in no event below the base of the Wolfcamp Formation." As the depth restriction also applies to Provision II, Assignment, on Page (3) and Additional Assignments, on Page (4), I inserted "but in no event below the base of the Wolfcamp Formation" in the appropriate places.


In the event the additions described above are unacceptable to Maralo, please advise. The other provisions of the Farmout Agreement submitted to us by Maralo on May 18, 1992 are acceptable.
