### STATEMENT OF CASE

## APPLICANT

Applicant seeks to initiate a high angle/horizontal directional drilling pilot project in the Undesignated Horseshoe-Gallup Oil Pool underlying all of Section 20, Township 30 North, Range 15 West, NMPM, San Juan County, New Mexico. Applicant seeks special operating rules therefor, a non-standard oil proration unit, a special project allowable, and special GOR assignment. Within said area the applicant seeks to dedicate up to 320 acres to a horizontal well to be drilled from an unorthodox surface oil well location in the SE/4SW/4 (Unit N) of said Section 20. Special rules and provisions would be promulgated for the area including the designation of a prescribed area limiting the horizontal displacement of the producing interval of the wellbore, special allowable considerations, and the adoption of a special gas/oil ratio of 4,500 to 1.
