STATEMENT OF CASE

APPLICANT

Applicant seeks to initiate a high angle/horizontal directional drilling pilot project in the Gallup Formation comprising the SW/4 of Section 24, Township 32 North, Range 13 West, NMPM, San Juan County, New Mexico. Applicant further seeks the formation of a 160-acre non-standard oil spacing and proration unit, special operating rules therefor, a special project allowable, and special GOR assignment.

Meridian Oil Inc. proposes to utilize its existing USA Well No. 2, located 930 feet from the South line and 1050 feet from the West line (Unit M) of said Section 24, by sidetracking and drilling a lateral borehole within said project area. Applicant further seeks special rules and provisions within the pilot project area, including the designation of a prescribed area limiting the horizontal displacement of the wellbore such that its producing interval be no closer than 330 feet from the subject area. Also to be considered will be special allowable provisions for a spacing unit larger than the statewide accepted 40-acre oil proration unit.
