


AMERICAN HUNTER EXPLORATION, LTD., ("American Hunter") through its undersigned attorneys, hereby makes application to the Oil Conservation Division for approval of an unorthodox well location and in support of its application states:

1. Applicant is the operator of Section 24, Township 27 North, Range 2 West, N.M.P.M., Rio Arriba County, New Mexico, and proposes to drill its Jicarilla 24N Well No. 1 at an unorthodox location 1000 feet from the South line and 2250 feet from the West line of said Section 24.
2. This well is proposed at a location within one mile of the boundaries of the West Puerto Chiquito-Mancos Oil Pool and applicant seeks an exception to the well location requirements of Rule 4 of the Special Pool Rules for the West Puerto Chiquito-Mancos Oil Pool to permit the drilling of the well at the above-described unorthodox location to a depth to adequately test the Mancos formation.
3. Approval of this application will afford applicant the opportunity to produce its just share of hydrocarbons underlying this spacing unit and will otherwise be in the best interest of conservation, the prevention of waste and the protection of correlative rights.

WHEREFORE, American Hunter respectfully requests that this application be set for hearing before an Examiner of the Oil Conservation Division on August 20, 1992, and that, after notice and hearing as required by law, the Division enter its Order granting this application and providing such other and further relief as is proper.
