
This letter is to advise you that Fortson Oil Company has filed an application with the New Mexico Oil Conservation Division seeking the force pooling of certain mineral interests in all formations to the base of the Abo formation, in and under the SW/4 SW/4 of Section 30, Township 19 South, Range 39 East, N.M.P.M., Lea County, New Mexico. Fortson Oil Company proposes to dedicate the referenced pooled unit to its Chance No. 1 Well to be drilled at an orthodox location 660 feet from the South and West lines of Section 30, to a depth of approximately 7800 feet, more or less, to test the Drinkard formation, East Nadine-Drinkard Pool and the Abo formation, East Nadine-Abo Pool and any other formation developed on 40-acre spacing.

This application has been set for hearing before a Division Examiner on December 3, 1992. You are not required to attend this hearing, but as an owner of an interest that may be subject to pooling, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.
