


Gentlemen:

This letter is to advise you that Yates Petroleum Corporation has filed the enclosed application with the New Mexico Oil Conservation Division seeking approval to drill its Beauregard ANP State Com No. 1 Well in the Abo, Cisco, Canyon, Strawn, Atoka and Morrow formations, Illinois Camp-Morrow Gas Pool. This well will be drilled to the Morrow formation at a location 660 feet from the North line and 1980 feet from the East line of Section 14, Township 18 South, Range 27 East, N.M.P.M., Eddy County, New Mexico. The E/2 of Section 14 will be dedicated to this well.

This application has been set for hearing before a Division Examiner on August 12, 1993. You are not required to attend this hearing, but as an owner of an interest that may be affected by the unorthodox well location, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.

Parties appearing in cases have been requested by the Division (Memorandum 2-90) to file a Prehearing Statement substantially in the form prescribed by the Division. Prehearing statements should be filed by 4:00 o'clock p.m. on the Friday before a scheduled hearing.
