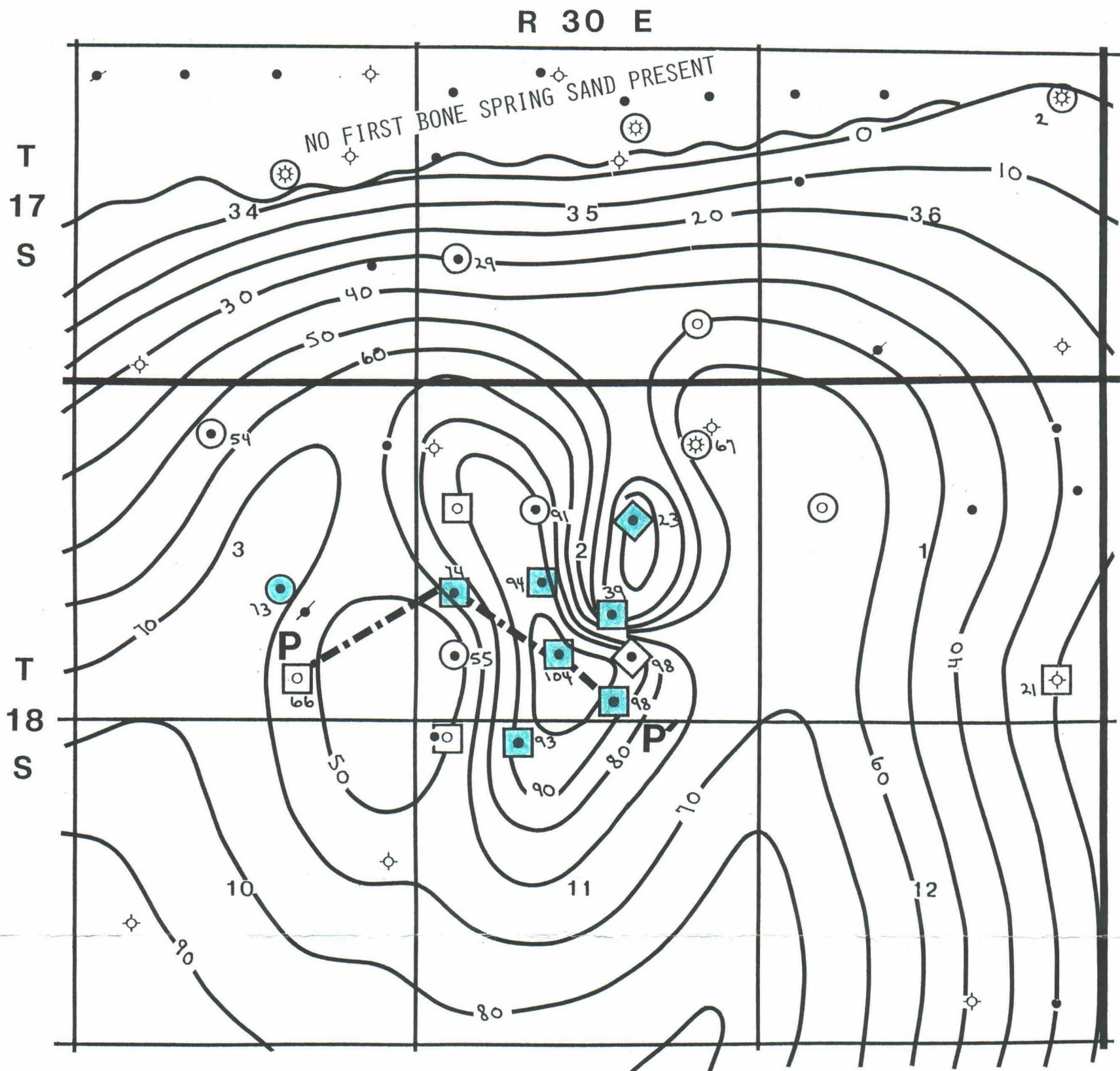
TOP/FIRST BONE SPRING SAND
