Comes now Samedan Oil Corporation, by its attorney, Karen Aubrey, and applies to the Oil Conservation Division of the Energy, Minerals and Natural Resources Department of the State of New Mexico for the expansion of the horizontal limits of the Cline-Tubb Pool, and for the establishment of Special Pool Rules and Regulations for the Cline-Tubb Pool, and in support of its application states:

1. Applicant is the operator of the Sarah B #2 Well, located 2310 feet FSL and 1653 feet FWL, (NE/4SW/4) Section 12, T23S R37E, Lea County, New Mexico N.M.P.M.
2. The Sarah B #2 well is currently producing from a perforated interval from 6130 feet to 6190 feet in the Cline-Tubb formation, and is within one mile of the present horizontal limits of the Cline-Tubb Pool.
3. The present horizontal limit of the Cline-Tubb Pool consists of the SE/4 of Section 11, Township 23S, Range 37E, Lea County, New Mexico, N.M.P.M.
4. The Cline-Tubb Pool is an oil pool, and is presently governed by statewide rules.
5. Under the statewide rules, oil wells completed in the Cline-Tubb Pool are

spaced on 40 acre spacing.

6. Applicant seeks the expansion of the Cline-Tubb pool to include the SW/4 Section 12, Township 23S, Range 37E, Lea County, N.M.P.M.

7. The present Gas-Oil Ratio for oil wells completed in the Cline-Tubb Pool is 2,000:1.

8. In order to effectively and efficiently produce the oil reserves underlying the SW/4, Section 12, Township 23S, Range 37E, Lea County, N.M.P.M., a limiting gas-oil ratio of 6,000 mcf/day/gas for each standard tank barrel of oil produced should be imposed.

9. Applicant proposes the following Special Pool Rules and Regulations for the Cline-Tubb Pool:

· Rule 1. Each Well completed or recompleted in the Cline-Tubb Pool or or in the Cline-Tubb formation within one mile thereof, and not nearer to or within the limits of another designated Tubb pool, shall be produced in accordance with the Special Rules herein set forth.

Rule 2. The limiting Gas/ Oil Ratio for the said Cline-Tubb Pool shall be 6,000 cubic feet of gas per barrel of oil produced; each production unit in said pool shall produce only that volume of gas equivalent to 6,000 multiplied by the top unit depth bracket allowable set for the pool

10. Applicant requests that the Special Pool Rules and Regulations set forth above should be applied retroactively to the date of first production from the Sarah B #2 well in the Cline-Tubb formation, September 12, 1993.






