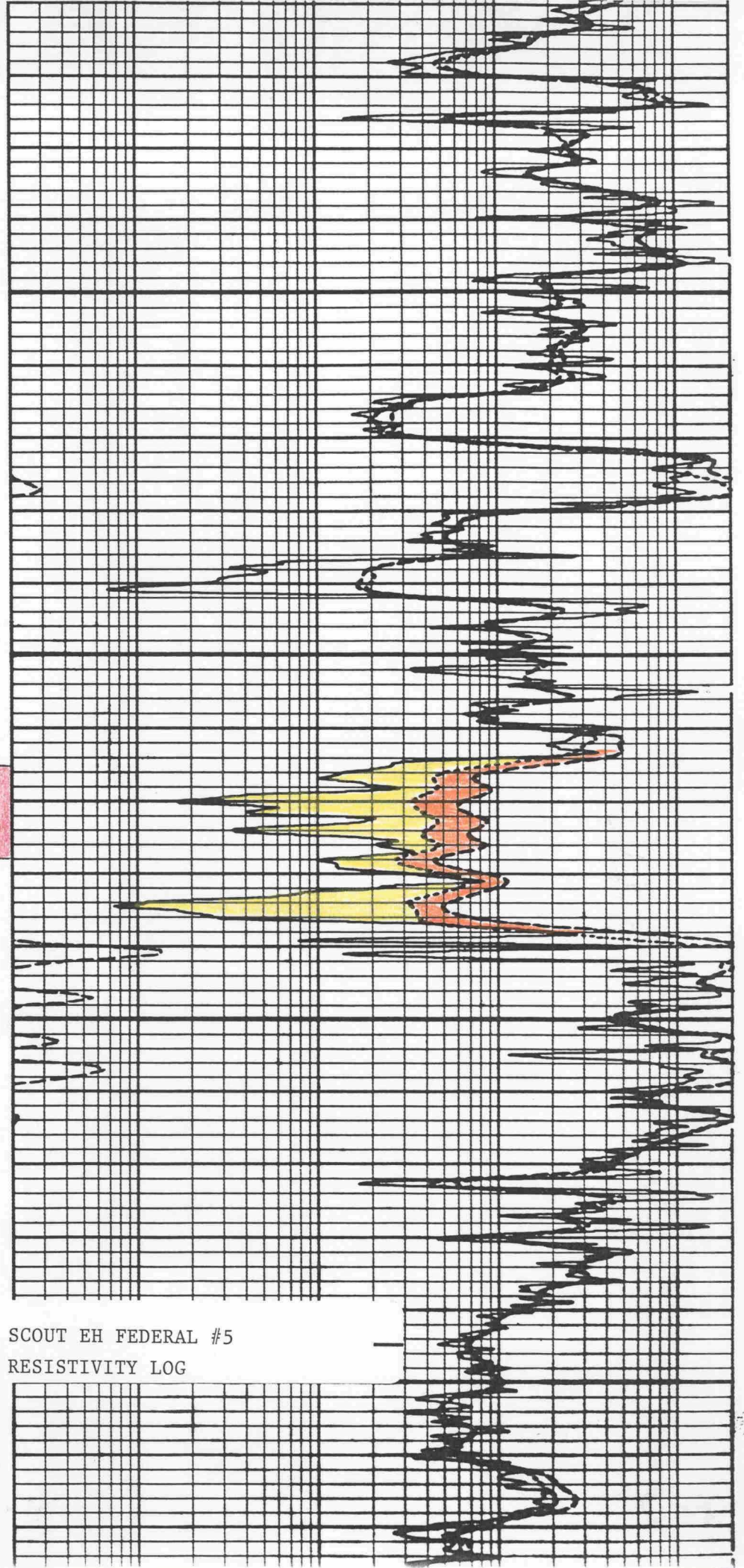
POROSITY LOG
