




Dear Mr. Lanning:

This letter is to advise you that Mewbourne Oil Company has filed the enclosed application with the New Mexico Oil Conservation Division seeking the force pooling of certain mineral interests in all formations from the surface to the top of the Wolfcamp formation, in and under the W/2 SE/4 of Section 32, Township 18 South, Range 34 East, N.M.P.M., Lea County, New Mexico. Mewbourne Oil Company proposes to dedicate the referenced pooled units to its La Rica "32" Well No. 1 to be drilled 1980 feet from the South and East lines of said Section 32.

This application has been set for hearing before a Division Examiner on May 12, 1994. 


