




To Whom it May Concern:



APPLICATION

YATES PETROLEUM CORPORATION ("Yates"), through its undersigned attorneys, hereby makes application to the Oil Conservation Division for an order amending Division Order No. R-9976 which was entered on September 24, 1993 to expand its pilot project area in the Pecos Slope-Abo Gas Pool and in support of this application states:

1. Yates Petroleum Corporation operates numerous wells which produce from the Abo formation in the Pecos Slope-Abo Gas Pool which is located in portions of Townships 4 through 8 South, Ranges 24 through 27 East, N.M.P.M., Chaves County, New Mexico.

2. By Order No. R-9976 entered on September 24, 1993, Yates Petroleum Corporation was authorized to implement a pilot infill drilling program within portions of the Pecos Slope-Abo Gas Pool, by drilling an additional gas well within each of certain gas spacing and proration units and to produce both wells within each of these spacing and proration units at unrestricted rates for a period of two years for the purpose of gathering geologic and engineering data to determine if additional infill drilling is necessary to

effectively and efficiently drain the Abo formation. This case will be reopened in August, 1995, unless reopened at an earlier date, for Yates to present the data it has obtained and to make recommendations to the Division concerning amendments, if any are appropriate, to the rules which currently govern the Pecos Slope-Abo Gas Pool.

3. The wells authorized by Order No. R-9976 have been drilled and data is being gathered for presentation to the Division.

4. Yates seeks authority to expand this pilot project within the Pecos Slope Abo-Gas Pool and drill additional wells on certain 160-acre spacing units. Additional development is necessary to accommodate sufficient data to determine if infill development is required to drain the Abo formation and to determine if additional sand stringers may be intersected and produced with additional wells.

5. The proposed project area should be expanded to comprise the following 160-acre tracts:

6. Attached to this application as Exhibit A and incorporated herein is a schedule which identifies each tract within the project area, the existing well thereon, the proposed additional wells and the offset operators.

7. Yates seeks authority to simultaneously dedicate and produce without restriction both wells on each additional 160-acre tract in the pilot project area until August, 1995, at which time this matter will be reopened by the Division to permit the applicant to present the data obtained by the proposed additional drilling and to determine if special pool rules authorizing a second well on each 160-acre spacing unit should be adopted for this pool.


8. Approval of this application will be in the best interest of conservation, the prevention of waste and the protection of correlative rights.
