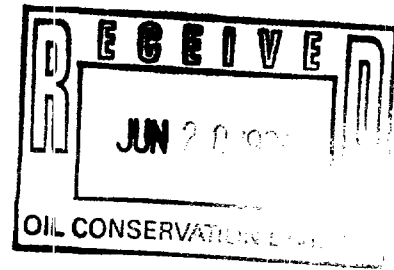

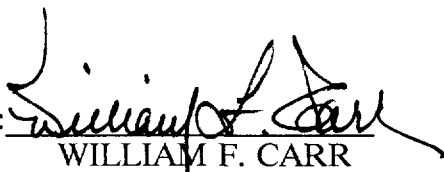

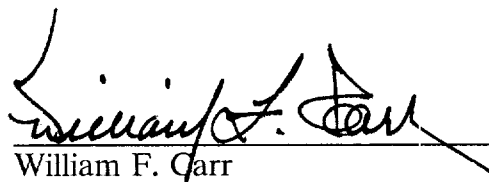

On May 19, 1994, we filed three separate compulsory pooling applications on behalf of West Largo Corporation for its three Chacra wells (Alamos Canyon #5, Alamos Canyon #10, and Alamos Canyon #11) located in the SW/4 of Section 4, the NW/4 of Section 9 and the SW/4 of Section 9, respectively, in T-21-N, R-6-W. Unfortunately, only the application for the Alamos Canyon #5 covering lands in the SW/4 of Section 4 appears on Docket No. 19-94. Case No. 11002 is presently set for examiner hearing on June 23, 1994. I do not know of the status of the published notice for the applications.

On behalf of the Applicant, we respectfully request that the applications for the Alamos Canyon #10 and Alamos Canyon #11 be consolidated with Case No. 11002 and heard on June 23, 1994. 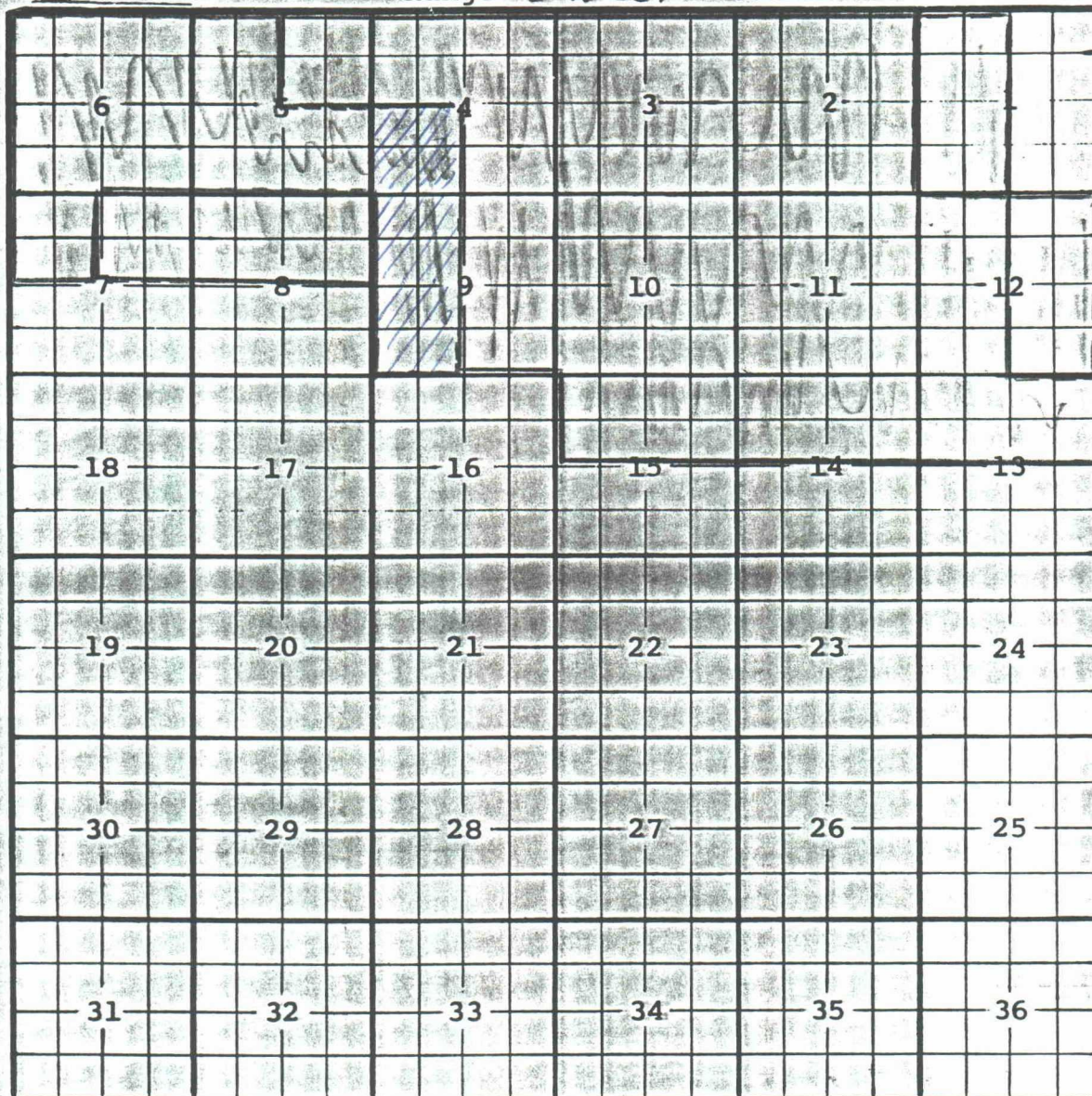
