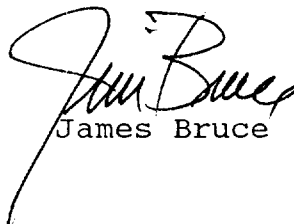

NOW, on this 31st day of October, 1989, the Commission, a quorum being present, having considered the record and being fully advised in the premises,

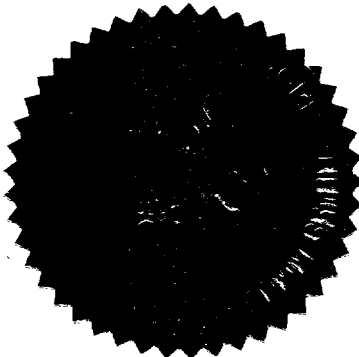
FINDS THAT:

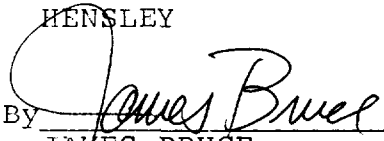
