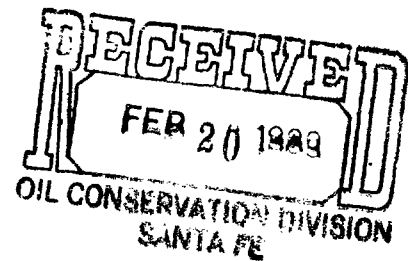

San Juan County, New Mexico

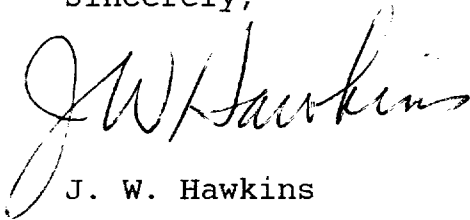
