TXO Production Corp. respectfully requests administrative approval to intentionally deviate the subject well from vertical to an orthodox bottom hole location under the New Mexico State Rule No. 111 (c). Attached you will find a plat showing the surface location of 1500' FEL & 100' FNL of Section 15, T-20-S, R-29-E, Eddy County, New Mexico, and the targeted bottom hole location of 1815' FNL & 825' FEL, Section 15, T-20-S, R-29-E, Eddy County, New Mexico. The surface location was surveyed by John West Engineering and field inspected and approved by the BLM.

TXO is deviating the well in compliance with the NMDCD order No. R-111-P for protection of the potash mining interests. The order states that the subject well be drilled outside the one-half mile from life mine reserve line as indicated by the plat. The potash lessee (Eddy Potash Company) supplied TXO with their life mine reserves which are indicated on the plat by the red line which goes through Sections 14 & 15.

Attached you will find a list of operators of proration of spacing units offsetting the subject well's unit along with their addresses and copies of the certified mail receipts giving notification of deviation.
