
The referenced well was completed March 21, 1989. This Strawn gas well was shut-in pending a better market for the gas. This well was drilled 360' from the north line and 1980' from the west line of Section 17. This is an approved excepted location.

I have requested by phone to you a hearing date of October 18, 1989. It is our desire to deviate this well and bottom in the Strawn 1000' west of the present location. The purpose of the deviation is to gain 50' of structure which would give us a higher gas deliverability from the well with less produced water.

Please let me hear from you as to what will be required of us at this hearing.




