

14 CHAIRMAN LEMAY: My confusion is that the de  
15 novo was filed actually before the case was heard by  
16 the Examiner as referring to a previous case.

17 MR. CARR: That is correct, and Yates wants  
18 to leave the de novo Application in place until they  
19 see the order.

20 CHAIRMAN LEMAY: But the de novo would  
21 actually apply to the new hearing, and not necessarily  
22 the old one, because the new hearing would -- That's  
23 confusion, I guess, on our part.

24 MR. CARR: We hope to avoid the confusion by  
25 being able to dismiss this between now and July the

1 19th.

2 CHAIRMAN LEMAY: I hope that's -- that will  
3 be the case. Thank you, Mr. Carr.

4 MR. STOVALL: Mr. Chairman, I think you  
5 brought up a good point before you actually continue  
6 the case, is that at that time should there be any  
7 desire on anybody's part, they may in fact have to  
8 bring a new de novo hearing because it will be a new  
9 order issued by the Division, so that's something to  
10 consider. But they have requested this case be  
11 continued at this time.

12 CHAIRMAN LEMAY: Well, at this point we'll  
13 continue that Case Number 9854 until the July 19th  
14 hearing and rule as to the merits of the de novo at  
15 that time if it's not resolved.




