In the matter of the application of the Oil Conservation Division of the Energy, Minerals and Natural Resources Department upon its own motion for an order for the creation and extensions of certain existing pools in Lea and Roosevelt Counties, New Mexico, and giving notice to all persons and parties interested in the subject matter thereof to show cause why such extensions should not be made.

This cause came on for hearing at 8:15 February 21, 1990, at Santa Fe, New Mexico, before Examiner Michael E. Stogner.

NOW, on this \_\_\_\_\_ day of February, 1990, the Division Director having considered the testimony, the record, the recommendations of the Examiner, and being fully advised in the premises:

FINDS:

(1) That due public notice having been given as required by law, the Division has jurisdiction of the cause and subject matter thereof.

(2) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the Atoka formation. Said pool to bear the designation of Tonto-Atoka Gas Pool. Said Tonto-Atoka Gas Pool was discovered by the Manzano Oil Company Wynell Federal Well No. 1 located in Unit I of Section 15, Township 19 South, Range 33 East, NMPM. It was completed August 25, 1989, in the Atoka formation. The top of the perforations is at 12,630 feet.

(3) That there is need for extensions to the West Corbin-Delaware Pool, the South Corbin-Wolfcamp Pool, the Gem-Bone Spring Pool, the Grama Ridge-Morrow Gas Pool, the Lane-San Andres Pool, the East Mason-Delaware Pool, the Mescalero Esacarbe-Bone Spring Pool, the Pearl-Queen Pool, the Quail-Queen Pool, the North Quail Ridge-Morrow Gas Pool, the Querecho Plains-Upper Bone Spring Pool, the Shipp-Strawn Pool, the Tonto-Seven Rivers Pool, and the North Young-Bone Spring Pool, all in Lea County, New Mexico, and the Tule-Pennsylvanian Pool in Roosevelt County, New Mexico.

IT IS THEREFORE ORDERED:

(A) That a new pool in Lea County, New Mexico, classified as a gas pool for Atoka production is hereby created and designated as the Tonto-Atoka Gas Pool, consisting of the following described area:

IT IS FURTHER ORDERED:

(1) That pursuant to Section 70-2-18, contained in Chapter 271, Laws of 1969, any well which by virtue of any of the pool extensions, is subject to pool rules providing for spacing or proration units larger than the one which is presently dedicated thereto, shall have 60 days from the effective date of this order in which to file new Form C-102 dedicating a standard unit for the pool to said well, or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division shall subject the well to cancellation of the allowable.
