We have received a Notice of Application for Water Disposal by Mobil Exploration & Producing U.S., Inc. in connection with their State Section 27 Lease, Well No. 1, Vacuum Devonian, South Field, Lea County, New Mexico. As yet, we have not received any notice or notice of publication of this application but having received the notice from Mobil, we are at this time making adequate pre-preparation requests in order that we will not have the same objections made to our subpoena duces tecum as we encountered in our last hearing. In this connection we request that at the time the notice of application is set, a subpoena duces tecum be issued to Mobil Producing Texas & New Mexico, Inc., requring the production of the following documents:

- A. All reports, documents, memoranda, notes, studies, correspondence, agendas, and minutes in the custody or control of Mobile, in connection with the salt water disposal from the Vacuum-Salado Study and the proposed salt water disposal in the Buckeye-Vacuum Field.
- B. A complete cost analysis made by Mobil in connection with the disposal of produced water from this production by which the water is to be transported and disposed under the State Well No. 1 and the total production and cost of operation of its interest in the North Vaccum Abo Unit area setting forth the profit realized from such production.
