STATEMENT OF CASE

APPLICANT

Manzano Oil Corporation plans to drill a 13,700 Morrow test called the Texaco Federal Com No. 2 well at an unorthodox location 1980 feet from the North line and 2310 feet from the East line of Section 14, T19S, R33E. The well is 330 feet from the western boundary of the E/2 of the section.

Manzano has a portion of the rights in the E/2 as a result of a farmout from Texaco, but has been unable to obtain 100% voluntary commitment of all the working interest owners despite its efforts.

Because of the multiple potential of Morrow, Atoka gas and Wolfcamp oil and others, the location is closer to the west side of the spacing unit for geologic reasons.




