1	WHEREUPON, the following proceedings were had
2	at 11:00 a.m.:
3	
4	EXAMINER CATANACH: At this time we'll call
5	Case 9975.
6	MR. CARROLL: Application of Meridian Oil,
7	Inc., for fourteen nonstandard gas proration units, San
8	Juan County, New Mexico.
9	EXAMINER CATANACH: Are there appearances in
10	this case?
11	MR. KELLAHIN: Mr. Examiner, I'm Tom Kellahin
12	of the Santa Fe law firm of Kellahin, Kellahin and
13	Aubrey, appearing on behalf of the Applicant, and I
14	have two witnesses to be sworn.
15	EXAMINER CATANACH: Any other appearances?
16	Will the witnesses please stand and be sworn
17	in?
18	(Thereupon, the witnesses were sworn.)
19	MR. KELLAHIN: My first witness is Mr.
20	Alexander, Mr. Catanach.
21	I'd like the record to reflect that Mr.
22	Alexander has previously qualified as an expert
23	petroleum landman.
24	EXAMINER CATANACH: The record shall so
25	reflect.

ALAN ALEXANDER,

the witness herein, after having been first duly sworn upon his oath, was examined and testified as follows:

EXAMINATION

BY MR. KELLAHIN:

- Q. Mr. Alexander, let me have you summarize for us what you're seeking to accomplish with this Application.
- A. Meridian Oil, Inc., is attempting through this Application to establish 14 nonstandard spacing units for the Fruitland Coal Formation in the area of 32 North, 9 West, which also consists for the most part of the federal unit by that same name in the San Juan 32-9 Federal Unit.
- Q. What is the basis for the request that the Division approve the 14 nonstandard proration units for coal-gas production? What's caused the problem that you've sought the nonstandard unit?
- A. The nonstandard units that we are seeking consist of irregular sections or portions of sections whereby we cannot establish in most cases a full 320-acre dedication that would consist of one-half governmental section.
- Q. In your opinion, will the granting of the 14 nonstandard units give you a comprehensive solution for

1 the Coal Gas spacing within this township? Yes, it will. 2 Α. Let's turn now to Exhibit Number 1, have you 3 Q. describe for us more specifically what you're seeking 4 5 to do. Exhibit Number 1 is Meridian's Application to 6 Α. the Commission asking to establish the 14 nonstandard 7 spacing units. 8 The application identifies each of those 9 Q. nonstandard units, giving the description by lot number 10 and then the total acreage per unit? 11 That's correct. The Application also has an 12 Α. area map attached to it. We have that same area map 13 14 presented later. It's a little easier to read. 15 fact, that is behind Exhibit Number 2. Let's turn to that, and go straight, then, to 16 the first display after the Exhibit Number 2 tab. 17 A. All right, the first display is an area land 18 map that gives an overall view of the 14 nonstandard 19 units that we're requesting. They're colored in blue. 20 21 The only difference between the dots and the full blue color is simply to show the Commission where one unit 22 23 ends and the other begins. It has no more significance 24 than that.

Q.

When we look at the row of nonstandard units

1 along the northern edge of the plat, if you move beyond that row of townships are we moving into the State of 2 Colorado? 3 Α. That is correct. 4 When we look at both ends of the row of 5 Q. nonstandard units, have you extended the nonstandard 6 7 units to a point, then, where you can make a convenient transition to standard-size spacing units or to spacing 8 9 units that have been previously approved as nonstandard units? 10 11 Α. Yes. On the eastern side of the boundary, we have, by prior hearing, recently established 12 nonstandard units that would butt up to Section 12 of 13 32-9, and there are orders in effect that would 14 continue to the south on those east-half units that 15 we're depicting. 16 17 Q. When we look at the far western side, then, of the top row of nonstandard units, I guess the first 18 19 section there is Section 11? 20 Α. The first section would be -- Of course, the sections that we're attempting to space would be 11 and 21 12. 22 23 Yes, sir, Section 11, I'm interested in the Q.

Oh, that would be Section 10, would be the

section west of Section 11.

Α.

24

first section shown there. 1 All right, what is the solution for that 2 section? Do you have an approved nonstandard unit for 3 that well for crude and coal-gas production? 4 I do not believe that we have an approved 5 A. nonstandard unit at this time for those sections. I'm 6 7 -- Let me look here just a moment and check. Yes, we should have an approved nonstandard 8 unit for that section. It contains the Stull Number 9 100 Fruitland Coal Well, so there should be an order in 10 effect for that. 11 12 When we go vertically, then, along the 13 western boundary of Range 9 West, and you have a number 14 of west-half nonstandard units --15 Α. Yes, sir. 16 -- do you see those? Two, four -- There's Q. six of them? 17 Yes, sir. 18 Α. You get down to the bottom in Section 7, and 19 20 that's not shaded in blue? 21 Α. That is correct. Why not? 22 Q. That section is not a part of the San Juan 32 23 Α. and 9 Unit, and since it is not a part of that unit, 24 Union Texas Petroleum that owns that acreage has 25

decided to form a north-half and a south-half unit in that section.

- Q. What do you accomplish with the approval of those six non-standard units along the western boundary of this township? What does that give you?
- A. Well, it -- What it does, and why we are requesting that the Commission approve those as nonstandard units, it would give us the ability to develop the fractional part of those sections that remain in the west half of each of those sections.

And it would also correspond with the drilling units that are currently in effect for the Mesa Verde or the Dakota Formation in which we have established revenue patterns already in existence there.

And it would also correspond with the language that's in the San Juan 32 and 9 Federal Unit Agreement that dictates that we should establish east-half and west-half units only within the unit area.

- Q. Why is it important to you as a landman to maintain consistency with the spacing units that are dedicated to the various kinds of production, whether it's Dakota, Mesa Verde or Fruitland Coal Gas?
- A. Well, one of the primary reasons is that we have established Division Orders and revenue patterns

that are established for the other formations, and it 1 also keeps us in context with the Federal Unit 2 Agreement language itself. 3 Let's turn now to the information shown 4 behind the first display that's folded out after 5 Exhibit 2. What have you enclosed in the exhibit book 6 at that point? 7 We have enclosed offset operator plats for Α. 8 each of the requested nonstandard spacing units, and on 9 each of those plats you will see the offset operator. 10 The plats also indicate -- If we have a 11 proposed well, we will have a well name at the top of 12 13 the plat and its footage for that well. To the best of your knowledge, are any of the 14 O. 15 wells actually drilled for any of these nonstandard units? 16 No, sir, they are not. 17 They're not yet drilled? And to the best of 18 **Q.** your knowledge, are all the proposed wells for any of 19 these spacing units to be at standard well locations? 20 That is correct. 21 Α. The pattern for standard well location with 22 Q. the Fruitland Coal Gas is in which quarter-quarter 23 sections? 24

They should appear in the northeast quarter

25

Α.

1 and the southwest quarter of the sections. After the plats that show the offsetting 2 0. operators, what have you included? 3 Before we get to Exhibit 3, there is some 4 C-102's? 5 Yes, sir, that's correct. We have included Α. 6 C-102 forms for each of the wells that we have staked 7 or that we have proposed, and they do not include wells 8 on each of the nonstandard proration units. 9 All right, let's turn now to the information 10 Q. behind Exhibit Number 3 and have you identify and 11 describe that. 12 13 Α. We have included two plats behind Exhibit 14 Number 3, the first of which is a plat that depicts 15 existing Fruitland Coal Wells in the area of the units that we are attempting to space. To the best of our 16 knowledge, we have found all of them, and we're showing 17 the acreage dedicated to those wells. 18 Behind that plat we show another plat that 19 depicts the existing Mesa Verde and Dakota spacing in 20 21 the area. In your opinion, Mr. Alexander, will approval 22 Q. of the 14 nonstandard proration units for the Fruitland 23 Coal Gas production provide Meridian and the various 24

other interest owners in each of these spacing units

1 with a comprehensive solution for the irregular-size townships that you're dealing with here? 2 Α. I believe that it will. 3 In each instance, will you also have a 4 Q. corresponding spacing unit for the balance of each of 5 those sections that would be standard --6 Α. That is correct. -- for those sections that, in fact, are not 8 Q. entirely encompassed within a nonstandard unit? 9 Yes, sir, where we have a west-half section 10 A. 11 available, there is a -- There will be a west-half section that will have a well on it, or it is a 12 13 proposed unit for a well at the minimum. For example, for a west-half nonstandard unit Q. 14 in 19, that leaves you available an east-half unit that 15 has a standard-size spacing unit within the tolerance 16 of the special rules? 17 Yes, sir, that's correct. 18 Α. 19 In no instance, then, are you stranding Q. 20 within a section or deleting or omitting within a section any acreage that might otherwise be dedicated 21 to Fruitland Coal Gas production? 22 23 No, sir, we are not. Α. 24 MR. KELLAHIN: That concludes my examination of Mr. Alexander. 25

1 At this point we would move the introduction of Exhibits 1 through 3. 2 EXAMINER CATANACH: Exhibits 1 through 3 will 3 be admitted as evidence. 4 **EXAMINATION** 5 BY EXAMINER CATANACH: 6 Mr. Alexander, do you know what the order 7 Q. numbers were that approved these nonstandard units for 8 the Mesa Verde and Dakota? 9 We checked that, and the -- All of these Α. 10 wells were drilled under administrative orders issued 11 by the Aztec office. 12 13 Q. Administrative orders. The formation of the nonstandard proration units never came to hearing? 14 15 Α. That's correct. And the reason for that, from researching our files and talking with the OCD 16 17 people over in Aztec, during that time period there were a number of these units established for the Mesa 18 Verde and Dakota, and here particularly in the 32 and 9 19 Unit, we have a Federal Unit Agreement that establishes 20 21 east-half and west-half as the appropriate spacing unit for these wells, and of course that agreement was 22 signed by all the regulatory agencies. 23 So the thinking back in those days was, that 24

established the spacing for these wells.

1 Now, we have since come to the Commission, 2 especially in the Fruitland Coal drilling program. Even though we have that language in the unit, we have 3 talked with the Commission and we felt that it was best 5 to come forward and get a specific order setting forth those nonstandard units. 6 I show on one of the exhibits here 7 0. I see. that Sections 7 and 8 are currently not developed in 8 the Dakota or Mesa Verde? 9 Yes, sir. Section 7 and 8 of 32 North, 9 10 Α. West? 11 Uh-huh. 12 Q. 13 That is correct, I'm showing that they are Α. not developed in either one of those formations. 14 Do you know if they have previously been 15 0. developed in those pools? 16 17 Α. No, sir, they should not have been. should have shown a dry-hole marker in there if there 18 19 had been any well in those. 20 0. Has -- Meridian has operated these nonstandard units in the other two formations since 21 their inception; is that correct? 22 There has been a change of operator in the 32 23 Α. and 9 Unit. El Paso Natural Gas operated that at one 24 We gave that up through some litigation to 25 time.

It was purchased by Amoco, and we have since 1 Tenneco. held a ballot to re-elect an operator in there, and 2 Meridian Oil, Inc., is the current operator of the 32 3 and 9 Unit. 4 Has it been Meridian's experience that the 5 Q. formation of these nonstandard units has been the best 6 way to develop these sections, the most efficient and 7 best way to develop these sections? 8 That's correct, and we have attempted, where 9 Α. possible, to follow the prior formation, to cause as 10 little disruption as possible. 11 Was the only offset operator Union Texas 12 13 Petroleum, Mr. Alexander? No, sir, if you'll look at the Application, 14 A. 15 Exhibit A to the Application which is behind Exhibit 1, you will see those parties that we have notified. 16 Those same parties are also reflected as you look 17 through the individual nonstandard proration unit plats 18 19 -- I'm sorry, the offset operator plats. You will see where those people occur, where they are. 20 21 0. And you have had no objection to any -- to the formation of any of these units from any of these 22 offset operators? 23 No, sir, we have not. 24 Α.

Are the locations that you -- the well

25

1	locations that you've depicted, are those have those
2	been staked, or are those final locations or just
3	tentative?
4	A. No, sir, they have been staked, and I do not
5	know of a reason that they would change at this point.
6	Q. And those are all standard locations?
7	A. Yes, sir, to the best of my knowledge.
8	Again, we don't have wells staked on all of the
9	requested units to date. Only a portion of it.
10	EXAMINER CATANACH: I have no further
11	questions of the witness. You may be excused.
12	Anything further in this case?
L3	MR. KELLAHIN: Mr. Falconi.
L4	EXAMINER CATANACH: Oh, I'm sorry, you have
L5	another witness, that's right.
L6	MR. KELLAHIN: A few questions for Mr.
L7	Falconi.
18	EXAMINER CATANACH: Okay.
L9	<u>JAMES D. FALCONI</u> ,
0 0	the witness herein, after having been first duly sworn
21	upon his oath, was examined and testified as follows:
22	EXAMINATION
23	BY MR. KELLAHIN:
24	Q. Mr. Falconi, for the record would you please
25	state your name and occupation?

1	A. My name is Jim Falconi, and I'm employed as a
2	senior reservoir engineer for Meridian Oil in
3	Farmington, New Mexico.
4	Q. Mr. Falconi, on prior occasions have you
5	testified on behalf of your company as a reservoir
6	engineer?
7	A. No, I haven't. As a drilling engineer.
8	Q. As a drilling engineer?
9	A. Yes.
10	Q. As a reservoir engineer, are you familiar
11	with the Coal Gas development that's taking place by
12	your company?
13	A. Yes, I am.
14	Q. And have you made an examination of the
15	request by your company for the 14 nonstandard gas
16	proration units that are on the docket for today's
17	case?
18	A. Yes, I have.
19	MR. KELLAHIN: We tender Mr. Falconi as an
20	expert reservoir engineer.
21	EXAMINER CATANACH: He is so qualified.
22	Q. (By Mr. Kellahin) Mr. Falconi, let me direct
23	your attention, sir, to Exhibit Number 4. Would you
24	turn to that display and identify it for us?
25	A. Exhibit number 4 is a Fruitland Coal net

isopach map of the subject acreage, and this map 1 depicts the net clean coal thickness of the Fruitland 2 Coal. 3 Is the net clean coal thickness one of the 4 0. criteria that Meridian uses to help determine the 5 location of Fruitland Coal Gas wells? 6 No, it is not. 7 Α. There are a series of criteria or geologic or 8 0. engineering components, then, to picking wells? 9 No, we pick locations based on Basin 10 Α. Fruitland Coal Pool rules and try to fit them within 11 the orthodox windows. 12 Within the criteria of the rules, there are 13 Q. 14 certain geologic and engineering factors or components 15 that go into picking a well, are there not? 16 No, we pick our locations to fit within the orthodox locations if we can. 17 When we look at the examination of the 18 0. nonstandard units in terms of well locations and the 19 orientations of those units, have you made an 20 21 examination to determine whether or not the approval of any of these nonstandard units precludes you from fully 22 developing the section? 23 We have reviewed that, and we have not found 24 Α.

that the locations that we have picked will eliminate

1 locations. Okay. The approval of the nonstandard units, 0. 2 then, will not require you to change any of your 3 proposed locations for those wells already picked in 4 terms of a well location? 5 That is correct. Α. 6 The orientation of the unit, that's not a 7 Q. significant criterion for you in picking a well 8 location, is it? 9 10 Α. No. 11 0. The rules require that the wells be drilled 12 if at all possible in the northeast or the southwest 13 quarter section of a section? 14 Α. That's correct. Will approval of any of these nonstandard 15 0. units cause you not to be able to do that? 16 No, approval of the locations as they're laid 17 A. out will not eliminate a well location. 18 Do you as a reservoir engineer see any reason 19 Q. 20 that the Division should not approve any of these nonstandard units? 21 22 Α. After review of the acreage, I don't see a 23 reason why they should not approve it. That concludes my examination 24 MR. KELLAHIN: of Mr. Falconi. We would move the introduction of 25

1 Exhibit Number 4. EXAMINER CATANACH: Exhibit Number 4 will be 2 admitted as evidence. 3 **EXAMINATION** 4 BY EXAMINER CATANACH: 5 Mr. Falconi, is it your opinion that the Q. 6 proposed nonstandard proration units can be efficiently 7 and effectively drained by the wells you've staked in 8 those units? 10 Α. Yes. EXAMINER CATANACH: I have no further 11 questions of the witness. You may be excused. 12 MR. KELLAHIN: We would also tender, Mr. 13 Examiner, Exhibit Number 5, which is the certificate of 14 notice. Here's the original, and I think we've given 15 you additional photocopies showing we've notified the 16 -- any potential offsetting operator of any of the 17 offsetting nonstandard proration units of this 18 19 Application, and to the best of my knowledge, we have 20 received no objection from any of those parties. 21 EXAMINER CATANACH: Okay, Exhibit 5 will be admitted as evidence. 22 23 Anything further? 24 MR. KELLAHIN: No, sir. 25 EXAMINER CATANACH: If not, Case 9975 will be
