

STATEMENT OF CASE

APPLICANT

Applicant is the operator of several wells, as listed in the Application, each of which is producing from the Avalon-Delaware Pool in Eddy County, New Mexico.

On July 1, 1980, the Commission, in Order No. R-63-68 established the Avalon-Delaware Pool. At this time, no special field rules or regulations for that pool have been established. The gas-oil ration limitation is, therefore, set by statewide rule 506, which creates a limitation of 2,000 cubic feet of gas per barrel of oil produced. Applicant seeks to have established a special field rule setting the gas-oil ratio limitation for the Avalon-Delaware Pool at 7,500 cubic feet of gas per barrel of oil produced.

The approval of this application will afford Applicant the opportunity to produce its just and equitable share of gas and oil, and such amendment is feasible in accordance with good conservation practices, and will otherwise prevent waste, and protect correlative rights.


