Dear Sirs:

I am proposing a re-entry to test two zones drill stem tested in the subject well between 7000 and 8000 feet. Please elect to participate or farm-out to me. If you choose to farm-out, I am requesting the following terms, based on the best information available to me.

Options at payout to convert 3% ORRI's to 50% WI's encumber tracts 2, 3, & 4, which are all apparently HBP by Monsanto's Covert Com #1 and Dagger Draw #1.


Tract 1 is federal acreage, held through March 1984 by a two year extension from the plugging of the S. P. Johnson in March 1982. A 4% ORRI on tract 1 increases to 10% at payout.

Apparently, Mr. Tom L. Ingram's interest is unaffected by options at payout and only involves tracts 2, 3, & 4. His NRI is 75%.

Excepting your acreage, I already control the proration unit to include the NW/4, SW/4, & SE/4 of the NW/4 and the SW/4 of the NE/4. Chama's Courtney P. Holstun lease is entirely left out of this non-standard proration unit. The Holstun lease is a proration unit in itself.

Thank you for considering this matter.
