A P P L I C A T I O N

Comes now Enstar Petroleum Company, and applies to the Oil Conservation Division of New Mexico, for an order pooling all mineral royalty interests in the Wolfcamp Formation underlying the SW/4SE/4 of Section 14, Township 15 South, Range 37 East, NMPM, Lea County, New Mexico, for the formation of a proration and spacing unit for the said production, and in support thereof would show the Commission:

1. Applicant is an owner of the right to drill and develop the SW/4SE/4 of Section 14, Township 15 South, Range 37 East, NMPM.
2. Applicant has drilled its McClure "E" No. 1 well at a standard location and has dedicated the SW/4SE/4 of said Section to the well which produces from the Wolfcamp Formation.
3. Applicant has sought to obtain the cooperation of all parties.

4. In order to obtain their just and equitable share of the production underlying the above lands, Applicant needs an order pooling the outstanding mineral royalty interests involved.


5. Those royalty owners who have not consented to join in the well and proration and spacing unit, with their addresses, to the best of applicant's information and belief, are as set forth on Exhibit "A" attached hereto.
