

APPLICATION

Comes Now, Getty Oil Company, by and through its undersigned attorneys, and hereby makes application to the New Mexico Oil Conservation Division for surface commingling of all gas production from the Dakota, Gallup, Chacra and Pictured Cliffs formations for wells in the Jicarilla "B" lease covering all of Section 5 and 6, Township 24 North, Range 5 West, and Sections 31 and 32, Township 25 North, Range 5 West; and the Jicarilla "C" lease covering all of Sections 27 and 28, the N/2 of Sections 33 and 34, and the S/2 of Sections 21 and 22, Township 25 North, Range 5 West, N.M.P.M., Rio Arriba County, New Mexico, and in support thereof states:

1. Applicant owns and operates the Jicarilla "B" and Jicarilla "C" leases in the following described lands in Rio Arriba County:

Township 24 North, Range 5 West, N.M.P.M.
Sections 5 and 6: All

Township 25 North, Range 5 West, N.M.P.M.
Sections 27, 28, 31, 32: All
Sections 33, 34: N/2
Sections 21, 22: S/2

2. Applicant operates a gas compressor on the Jicarilla "C" lease which has additional capacity.

3. Applicant has administrative approval to surface commingle South Blanco Pictured Cliffs and Otero Chacra gases with the Otero Gallup gas on the Jicarilla "C" lease.

4. Applicant has administrative approval to surface commingle the Jicarilla "B" Otero Gallup gas with the Jicarilla "C" gas gathering system.

5. Applicant has administrative approval for downhole commingling of the Gallup and Dakota formations on the Jicarilla "B" and "C" leases.

6. Applicant has administrative approval for downhole commingling of the Chacra and Pictured Cliffs gases on the Jicarilla "B" and "C" leases.

7. Applicant seeks blanket approval for surface commingling of gas production from the Dakota, Gallup, Chacra, and Pictured Cliffs Formations for all existing wells and all wells subsequently drilled on the lands described in Paragraph 1.

8. Granting this application will be in the best interest of conservation, the prevention of waste and will not impair the correlative rights of any offset operators.

WHEREFORE, Getty Oil Company requests that this matter be set for hearing on July 11, 1984, and that after notice and hearing as required by law, the Division enter its Order granting this application.
