20 subject to the provisions of the Pricing Act.

22 applications at this time. We do have a witness available
23 to testify in the event that the Commission wishes to hear
24 testimony on the question of whether or not the gas is going
25 into the interstate market.

MR. RAMEY: So you want to
withdraw the applications and then dismiss the case.
