COMES NOW, HILLIARD OIL AND GAS COMPANY, by and through its attorneys, KELLAHIN & KELLAHIN, and applies to the New Mexico Oil Conservation Division for approval of an Unorthodox Gas Well location 1,980 feet from South line and 460 feet from the West line of Section 26, Township 15 South, Range 30 East, Chaves County, New Mexico, NMPM, Cedar Point-Strawn Gas Pool, said location being in the NW/4 SW/4 of said Section 26, thereby requiring an exception to Rule 4 of the Cedar Point-Strawn Pool Rules, and in support thereof would show:

1. Applicant has the right to drill and develop the W/2 of the SW/4 of Section 26, Township 15 South, Range 30 East, Chaves County, New Mexico.

2. Applicant proposes to drill his Federal B No. 1 Well at an Unorthodox Gas Well location 1,980 feet from the South line, 460 feet from the West line of Section 26, Township 15 South, Range 30 East.

3. Applicant proposes to dedicate the W/2 of the SW/4 of said Section 26 to the Well.

4. Applicant proposes to attempt a completion in the Cedar Point-Strawn Gas Pool.

WHEREFORE, Applicant requests that this matter be set for Hearing, and that after Notice and Hearing the Application be granted as requested.
