Gentlemen:

In response to your letter dated July 13, 1987, please be advised that we continue to classify the referenced well as a producing well. In July, 1986, a high line pressure was suddenly encountered in the Northwest Pipeline system. The pressure was too high for the referenced well to produce and the well logged off. As indicated on our Hardship application, production is difficult to reestablish in this well; however, we plan to perform swabbing operations on this well before the end of the year and expect it to resume production at that time.

As demonstrated by the above described behavior of this well, it remains difficult to reestablish production in this well if production ceases, and we request that this well's classification as a Hardship Gas well be extended by the Division.

Enclosed is a copy of the Hardship Classification extension we received last year.
