Confirming the telecon of August 27, 1984, between Mr. J. C. Allen of this office and Mr. R. L. Stamets, Amoco Production Company respectfully requests the application for the referenced unorthodox well location be set for Examiner hearing on September 19, 1984. As shown on the attached Unit map, the well is located 660 feet FSL and 660 feet FWL of Section 24, T-18-S, R-33-E, Harding County, New Mexico. The proposed location is in the Bravo Dome 640-Acre Area and requires an unorthodox location due to geological reasons.
