Our firm represented Oxy USA Inc. (formerly Cities Service Oil & Gas Corporation) in the two prior hearings in this case and now enters our appearance in its behalf in the referenced case set for hearing on October 31, 1991.

Because of prior commitments by my expert and me, we are unable to attend either the October 31st or the November 7th hearing and request that this matter be continued to the Examiner Hearing scheduled for November 21, 1991.

This case appears on the docket as a result of ordering paragraph (2) of Order R-7737-A which provides:


(2) This case shall be reopened at an examiner hearing in October, 1991, or two years from the date of first production from the subject area, whichever occurs first, at which time the operators in the subject area may appear and show cause why the West Bravo Dome Carbon Dioxide Gas Area should not be developed on less than 640-acre spacing and proration units.

Because production history from wells in the subject area is still not available, there is no basis for making any changes in the rules nor any reason to make the rules permanent at this time. We have contacted both Chevron USA and Amer:da Hess Corporation, the two other major operators in the pool

and they concur in this request. Accordingly, we would request that the case be re-advertised to indicate that in the absence of objection, the current pool rules, including 640 acre spacing, should continue to be temporary for a period of two years following the date of first production.

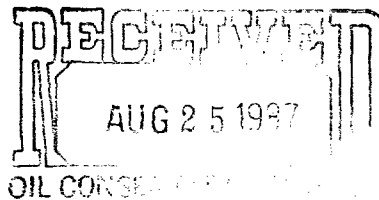
