AUBREY: 9 Q Would you state your name and occupation, 10 please? 11 My name is Dan Kernaghan. My occupation 12 is Division Operations Manager for Anadarko Production Com-13 pany in Midland, Texas. 14 0 Mr. Kernaghan, have you testified ore-15 viously before the Commission and had your qualifications 16 made a matter of record? Α Yes. 17 And are you familiar with the applica-18 tions of Anadarko in Cases 8379 and 8380? 19 Yes, I am. Α 20 Q Will you briefly state what Anadarko 21 seeking by those two applications? 22 Α Anadarko is seeking permission to convert 23 three currently producing wells to water injection in two 24 waterflood projects that have been previously approved. 25 MS. AUBREY: Mr. Examiner, are

the witness' qualifications acceptable?

MR. QUINTANA: The witness' qualifications are acceptable and he will be admitted as an expert witness.

MS. AUBREY: Thank you.

Q Mr. Kernaghan, have you prepared certain exhibits for the consideration of the Examiner today?

A Yes. Yes, I have.

Q Let me refer you to what we've marked as Exhibit One, which is a land plat. Can you look at that, sir, and explain what that shows?

A This shows the location of the three wells which we're requesting permission to convert to water injection and all the surrounding wells and leases within two miles of these conversions.

Q That's an exhibit that's required by the Form C-108, is that correct?

A Yes, that is correct.

Q Let me refer you to Exhibit Two now. Exhibit Two shows the proposed injection wells and the plugged wells?

A This well shows the proposed injection wells with blue triangles and two plugged wells that are within the half mile radius, or exactly at a half mile in one case.

Q Does this, the application today seek conversion wells to injection wells in two separate water-

6 1 floods, is that right? 2 That is correct. 3 For the examiner, can you refer to Exhi-0 4 bit Two and explain where those two projects are on that ex-5 hibit? 6 Α Okay. The R-3 and R-8 Wells in Section 7 in the north half of Section 10, are part of a project 8 that was originally called our Federal "O" Waterflood. The "Q" lease, the project started in the northwest quarter of Section 3 and includes the southwest of 3, the southeast of 10 3, and the north half of 10. 11 And where is the other waterflood project 12 located? 13 The other waterflood project is in the 14 south 480 acres of Section 2 of 17, 30. It's our Burnham 15 Grayburg-San Andres Unit. 16 second one is Order The 4610, the Burnham. The first one, Order 4049. 17 And both of those projects have been 18 previously approved by Commission orders, is that right? 19 Yes, that is right. Α 20 0 Let me refer you to Exhibits Three and 21 Four now. 22 Okay. A 23 Can you identify these for the Examiner? 0 24 A These are the orders that we previously mentioned, R-4049 and R-4610. 25

| 10 | A Okay. This, both of these waterflood                       |
| 11 | projects are 5-spot water injection patterns. They've been   |
| 12 | in place for six or eight years, the "Q" Leaseactually lon-  |
| 13 | ger than that.   |
| 14 | They've been very successful. They've                        |
|    | recovered additional oil.                                    |
| 15 | We propose to fill out the pattern on the                    |
| 16 | "R" Lease to complete a 5-spot pattern.                      |
| 17 | On the Burnham Unit we propose to densify                    |
| 18 | this pattern to a 20-acre well spacing or 40-acre pattern    |
| 19 | volume unit area in a pilot basis with this well.            |
| 20 | Q Have you prepared an exhibit which shows                   |
| 21 | the proposed operation of the three wells that you would in- |
| 22 | tend to convert to waterflood?                               |
| 23 | A Yes, I have. It's included as Exhibit                      |
| 24 | Number Five.   |
|    | Q Would you refer to that, sir.                              |
| 25 | A Yes.   |

Q And briefly go through it. Describe for the Examiner, for instance, what the proposed injection rates are?

A Okay, our injection, the volume we anticipate is 200, 250 barrels a day per well. The injection pressure, we're satisfied with the .2 pounds per foot to start with and we'll submit step rate tests or other data of an equivalent nature to justify higher injection pressures.

Q In the even that you require higher injection pressures.

A As we need them. It's a closed system. The injection water is approximately 80 percent produced water and 20 percent fresh make-up water from the Ogallala formation purchased from the Yucca Water Company.

Q And what's the source of the produced water?

A It's the Ogallala -- the produced water is Grayburg-San Andres.

What is the injection zone?

A Grayburg-San Andres.

Q Have you identified and can you give the geologic name of the sources of underground drinking water in the area?

A The Rustler formation in the range of 400 to 480 feet.

Q Let me refer you now to your next exhibit which I think we've marked as -- it's Number Six. Can you

look at that. That's the tabulation of wells in the area, is that correct?

A That's correct. Exhibit Six is a tabulation of all the wells within the half mile radius of any one of the three proposed conversions.

It shows the completion data on all of these wells, whether water injection or producing or plug-

I now refer you to the attachment to Exhibit Six, which I believe are schematics.

A The last five pages of Exhibit Six are schematics of first the three proposed conversion wells, the Federal R-3, the Federal R-8, and the Burnham Grayburg-San Andres Unit 6-1. The final two pages are schematics of the two plugged wells shown in red, shown with red circles in Exhibit Two.

These exhibits show the condition of the wells at the present time.

MS. AUBREY: Mr. Quintana, I think that what you're looking at is marked on your copy as Exhibit Seven. Am I correct?

MR. QUINTANA: Yes.

MS. AUBREY: Okay.

Q Referring you to the schematics, Mr. Kernaghan, does it show -- do the schematics show the proposed injection interval?

A They do, in the Metex and Premier zone

10 1 of the Grayburg zone for the most part; the Lovington zone 2 in two of the wells. 3 Let me refer you back to Exhibit Number 4 Mr. Kernaghan. You show two plugged and abandoned 5 wells on that exhibit. 6 Yes. 7 Does Exhibit Number Seven contain schema-8 tics on those two wells? The last two pages are schematics of A 9 those two wells, the Apollo Oil Company W. D. McIntire No. 10 8-D, which is in Unit B of Section 9, 17, 30, and the Texmex 11 Marrow State lease, which is now operated by J. Cleo Thomp-12 son. It's in Unit C of Section 2, 17, 30. 13 Both of these wells are plugged. We have 14 no -- we feel like they're both adequately plugged to con-15 tain the fluids. 16 Mr. Kernaghan, have you prepared or had prepared for you a water analysis -- an analysis of 17 fresh water in the area? 18 Yes, we have. It's shown as Exhibit --19 it must be Exhibit Six. 20 Oh, I think it's Eight, Dan. O 21 Is it Eight? A 22 Yes. 0 23 MR. TAYLOR: We do not have Ex-24 hibit Six. 25 MS. AUBREY: No, we have an Ex-

hibit Six. I'm going to get to that one in just a minute.

Our exhibits numbers got all messed up.

MR. TAYLOR: Okay.

A Exhibit Eight is the analysis by Martin Water Laboratories of the fresh water, water taken from a windmill in Unit B of Section 24 of the township to the north.

Raw water taken from our plant, which is the make-up water, basically. It's fresh Ogallala water.

Produced water from the West Square Lake
Plant and produced water from the Burnham Unit and produced
water from the "R" Lease.

Q And I believe the last page on that exhi-

A The last page is just Mr. Martin didn't know what -- what the purpose of this analysis was. He just, he gave us a letter saying that the windmill water looks kind of bad but it's just plain Rustler water. It's not contaminated.

Q Let me refer you now, Mr. Kernaghar, to what we have marked as Exhibit Six.

A Six are three logs, a log on each of the wells we propose to convert to injection. They show the perforations in the well, the zones of -- the productive zones that we're injecting water into and in some cases some other limited information about the completion.

Q You show the proposed injection zone?

| 11 | through it into the zones that are open.                     |
| 12 | Q What kind of surface monitor do you pro-                   |
| 13 | pose?  |
| 14 | A We propose to leave the valve open on the                  |
|    | bradenhead at the surface where we can detect a water flow.  |
| 15 | Ω Mr. Kernaghan, have you found any evi-                     |
| 16 | dence of any open faulting or other hydrological connection  |
| 17 | between the proposed injection zone and any sources of fresh |
| 18 | water?   |
| 19 | A No, I have not.  |
| 20 | Q Now, sir, let me refer you to the exhibit                  |
| 21 | which consists of your return receipts. Do you have a copy   |
| 22 | of that here?  |
| 23 | A Yes.   |
|    | Q Are those return receipts from your noti-                  |
| 24 | fications from the surface owners and any offsetting opera-  |
| 25 | tors of the proposed waterflood injection?                   |

QUINTANA: 7 0 Mr. Kernaghan, the two plugged and aban-8 doned wells you have denoted on your -- on your map here, that you show schematics of --9 Α Yes. 10 -- have you been in contact with our Dis-11 trict Office to determine if they have been plugged in con-12 junction with their needs? 13 We have been in contact to the extent Α 14 that we've picked up the files from there. We copied the 15 files from the District Office. We have not talked to Mr. 16 Clements. The files reflect, you know, both 17 of these wells had --had plugging information on them. The 18 well in Section 9 had rather extensive plugging information 19 on it. They appear to have done a very good job on that 20 well. 21 The well in Section 9, Well No. 8. Q 22 For Apollo, yes. A 23 The open hole interval that is -- that is 24 not filled with cement or mud or anything, that just --It's filled with mud. 25 Α

15 1 With mud? Q 2 Α Has to -- by the nature of the plugging 3 it has to be filled with something. 4 Is that -- is that interval, that appro-5 ximate open interval from -- to TD of 3261, the approximate 6 open interval --7 It's 500 feet. Is it the approximate open interval of 8 Q your injection zone, also? Α Yes, we probably have one zone above 10 It's probably the Premier and the Lovington. I'd 11 have to correlate, but I suspect it's the Premier and the 12 Lovington. 13 Our Metex zone is -- is at 2780, so it 14 probably includes all three zones. 15 Now, on Well No. -- the Merrill State No. 3, which is in Section 2. 16 Α Yes. 17 That shows to have five sacks to the sur-18 face and five sacks at the --19 The shoe of the surface pipe. 20 -- surface pipe, and then fifteen sacks O 21 and you're not sure exactly as to where -- where -- at what 22 depth. 23 Α This one was kind of fouled up. Their 24 records showed that the -- that the casing was cut off inside the surface pipe, but -- but the location of their plug 25

indicated that no, it probably wasn't, it was down below the surface pipe, and that's the -- the interpretation that I took.

This well is offset on either side 330 feet away by producing wells. J. Cleo Thompson has cone in in between the four original producers on this lease and drilled three new producers.

Q Mr. Kernaghan, would it be too much trouble if I requested that you contact our District Offices to determine if these -- plugging of these two wells that we have been talking about in the last ten minutes are in accordance with what they believe to be adequate plugging?

A We'd be glad to. You know, we'd be quite satisfied if you just write into the order that we contact, that we have the District Office concurrence to either the correct plugging of these wells, a monitoring program or replugging, prior to us being issued a permit.

Q Fine. That about does my -- you said what I wanted to hear you say.

## CROSS EXAMINATION

BY MR. TAYLOR:

Q Excuse me, did you testify as to the nearest water well or spring to these two units?

A The nearest water well to my knowledge is the windmill that we took the sample from. It was the -- it was a sample from the closest windmill that we knew of, and
