NOW, on this 18th day of December, 1984, the Division Director, having considered the record and the recommendations of the Examiner, and being fully advised in the premises,

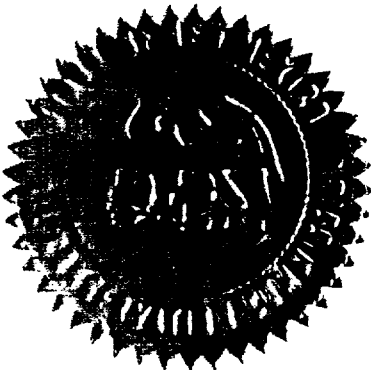
FINDS THAT:

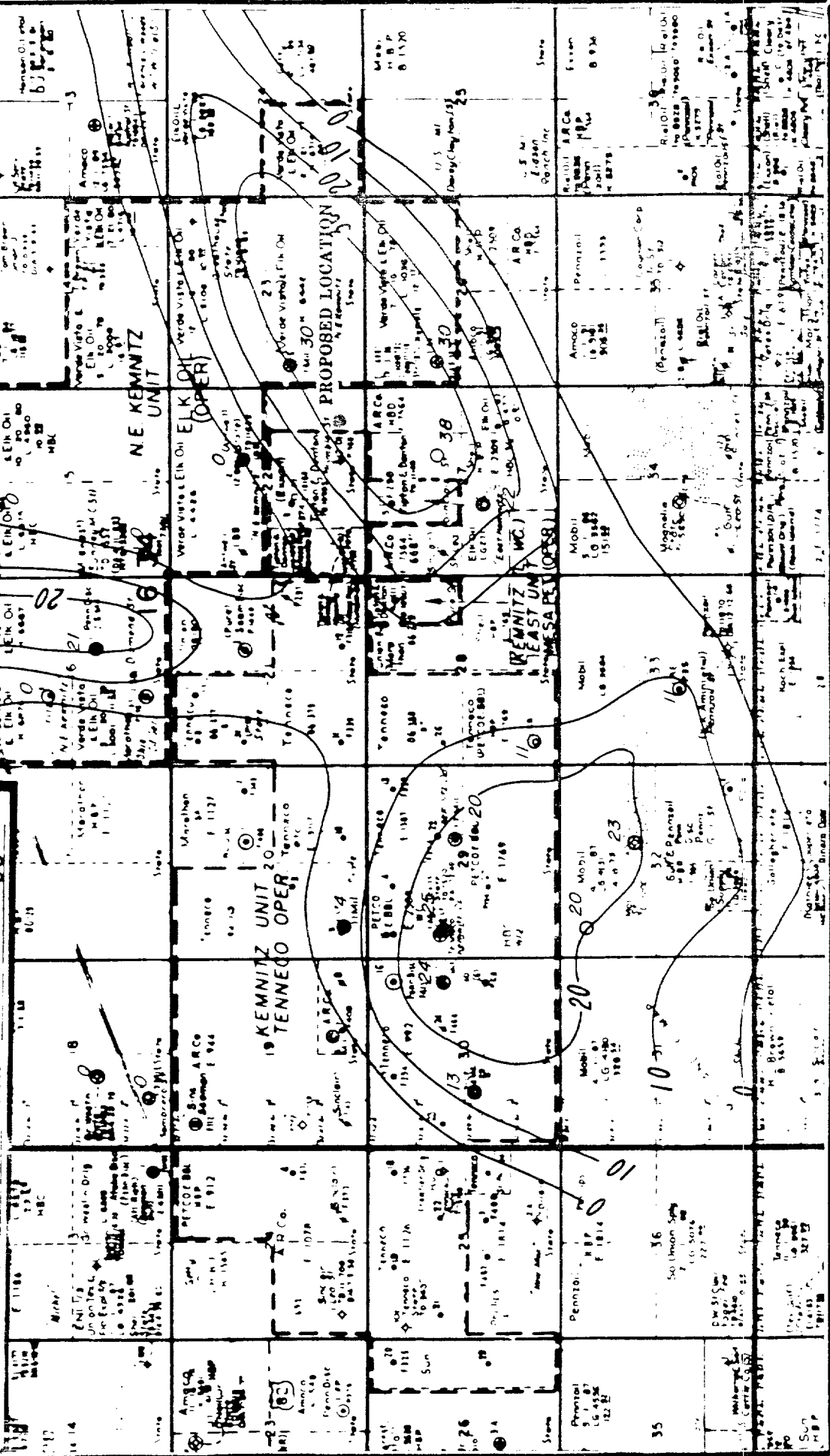

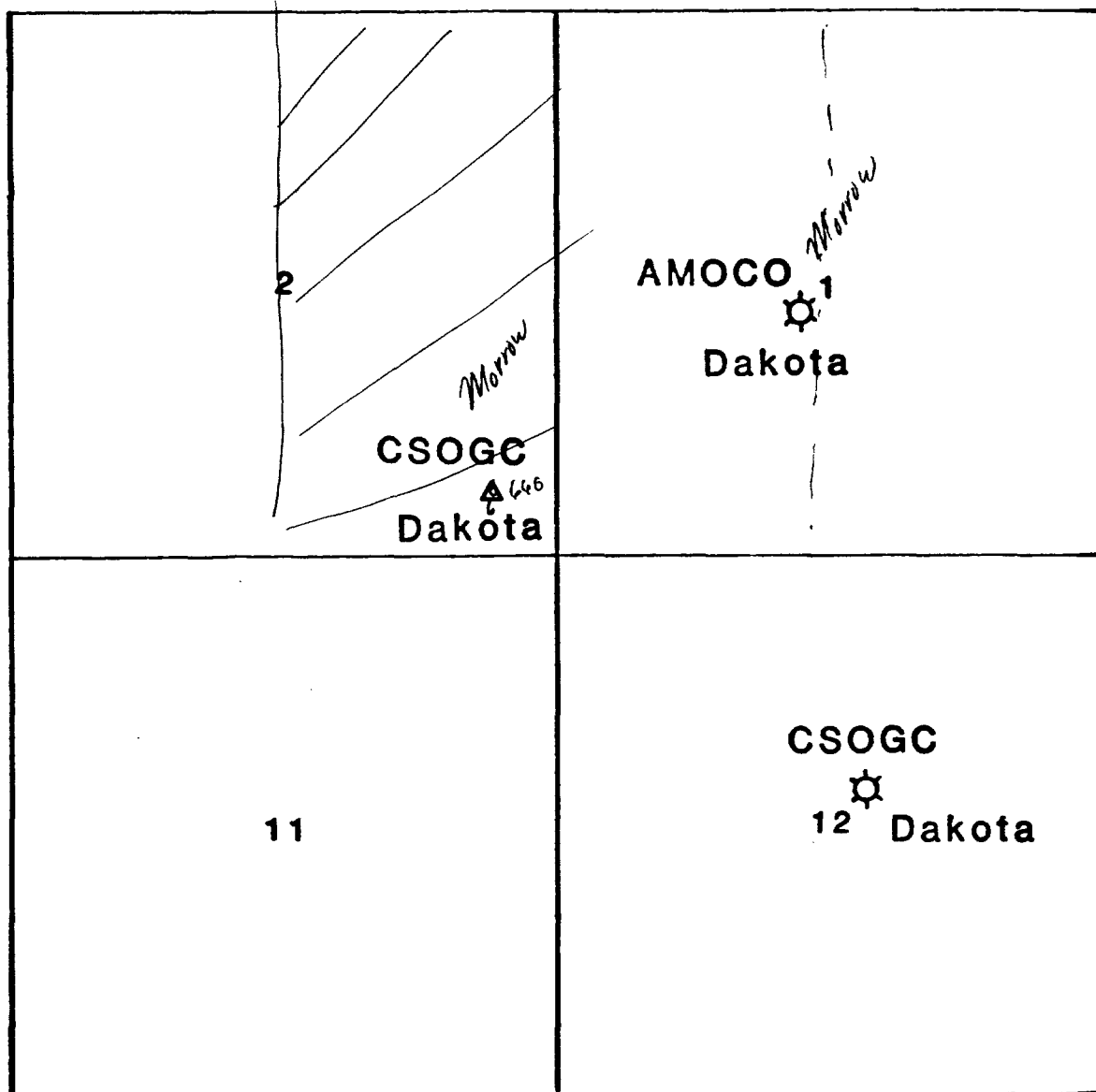

Proposed Changes to OCD Staff Rule 1207

- 1207(a) 2. In the cases of applications for approval of unorthodox locations:

NEW

Actual notice shall be given to the operator of each well on each adjoining or cornering tract of land or spacing unit currently producing from the same formation toward which the unorthodox location is to be moved. Provided, however, if the applicant is the operator of the well in an adjoining or cornering tract of land or drilling and spacing unit, currently producing from the same formation, toward which the well location is proposed to be moved, the applicant shall provide actual notice to each working interest owner in such well.

Actual notice shall also be given to each lessee and each unleased mineral owner in an adjoining or cornering tract of land or spacing unit toward which the unorthodox well is to be moved if the tract or unit does not have a well producing from the same formation. If the proposed well lies within or offsets a Division designated potash area subject to special rules, actual notice shall be given to each potash operator within one mile of the proposed location. Actual notice shall be given by certified mail (return receipt requested).

- 1207(a) 4. In the case of applications for adoption of, or amendment of, special pool rules:

Actual notice shall be given to all operators within the existing or proposed pool boundaries and all ~~[these-of]~~ operators within one (1) mile of such boundaries. Such notice may be provided by certified ~~[regular]~~ mail (return receipt requested).

- 1207(a) 5. In the case of application to amend special rules of ~~[affecting]~~ any Division designated potash area, actual notice shall be given to each ~~[any-affected]~~ potash owner, each ~~[or]~~ oil or gas operator, and each ~~[or]~~ each unleased mineral owner within the designated area. Such notice shall be provided by certified mail (return receipt requested).
