FIRST AMENDED APPLICATION FOR NON-STANDARD LOCATIONS

Applicant states:

1. That the applicant is the operator of the S/2 of Section 13, T7S, R33E, Roosevelt County, New Mexico.

2. Applicant proposes to drill the following wells at non-standard locations:

(a) 1,310 feet from the south line and 1,310 feet from the west line of said Section 13;

(b) 1,310 feet from the south line and 2,630 from the west line; and,

(c) 1,310 feet from the south line and 1,330 feet from the east line.

3. Applicant proposes to drill the foregoing wells to the San Andres Formation to the approximate depth of 4,500 feet.

4. That applicant proposes to drill the foregoing wells in conjunction with an enhanced recovery project for the S/2 of said Section 13.

5. That the approval of this Application will be in the best interest of conservation of oil and gas.


WHEREFORE, applicant requests:



APPLICATION FOR NON-STANDARD LOCATIONS

Applicant states:

1. That the applicant is the operator of the S/2 of Section 13, T7S, R33E, Roosevelt County, New Mexico.

2. Applicant proposes to drill the following wells at non-standard locations:

- (a) 1,310 feet from the south line and 1,310 feet from the west line of said Section 13;
- (b) 1,310 feet from the south line and 2,630 from the west line; and,
- (c) 1,310 feet from the south line and 2,650 from the east line.

3. Applicant proposes to drill the foregoing wells to the San Andres Formation to the approximate depth of 4,500 feet.

4. That applicant proposes to drill the foregoing wells in conjunction with an enhanced recovery project for the S/2 of said Section 13.

5. That the approval of this Application will be in the best interest of conservation of oil and gas.


